Plan Summary 2023-24

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Schools in the Long Beach Unified School District are widely recognized for their innovation, academic rigor, educator professional development, and greatness in athletics, the arts and more. A team of more than 12,000 full-time and part-time employees remains deeply committed to building upon those successes, especially for students who, for a variety of reasons, may need extra support. Established in 1885, LBUSD now educates over 60,000 students, from preschool to high school, in 85 schools located in the cities of Long Beach, Lakewood, Signal Hill, and Avalon on Catalina Island. LBUSD serves one of the most diverse large cities in the United States. About 59% of students are Hispanic,12% African American, 12% white, 7% Asian, 6% Multiple Race, 3% Filipino, 1% Pacific Islander. Approximately 15% of students are English Learners, 64% socioeconomically disadvantaged, and 9% homeless/foster youth. The District has developed a detailed Learning Acceleration & Support Plan that incorporates multiple funding sources and provides for targeted support such as literacy and math specialists, equity training for teachers, expanded tutoring and summer programming, a new way of collecting data to monitor student progress, the opening of wellness centers on every high & middle school campus, and the launch of a Black Student Achievement Initiative. These and many other efforts detailed in this document are designed to help LBUSD maintain its status as a leading school system known for its pursuit of excellence and equity.

Key to the district's success is its work with community, higher education, and industry partners. LBUSD, Long Beach City College, and California State University, Long Beach, have worked in collaboration with local, regional, and national institutions to create seamless, pre-kindergarten to postgraduate-school education. This partnership includes the Long Beach College Promise, which provides additional support to help more students prepare for and succeed in higher education. LBUSD has also established educational partnerships with more than 1,300 local businesses, which recognize the district's role in developing a well-educated, highly skilled workforce. Approximately 12,000 Volunteers in Public Schools (VIPS) assist teachers and students in classrooms. Long Beach schools have been visited and praised by the nation's president, attorney general, four secretaries of education, former Secretary of State Gen. Colin Powell, and other high-level officials seeking to replicate LBUSD's successes. Local schools have won numerous California Distinguished, National Blue Ribbon, and National Green Ribbon awards.

Vision 2035 and Rethinking Engagement

This year, LBUSD engaged in an intense process for visioning and strategic planning.

Taking a step back from the LCAP, the District embarked on a larger broader engagement and strategic planning process where all funding and programmatic resources would be explored through an equity-design engagement process. Equity design is a type of design-thinking where the District intentionally engaged communities often

underrepresented to ensure their voices were heard and had a seat at the table. Additionally, by taking key components of design-thinking where ideas, thoughts, and inputs were generated by both internal and external stakeholders.

This process allowed the District to expand their engagement strategy and took this process as an opportunity to engage our internal and external stakeholders through multiple strategies. Our educational partners were part of the core engagement and we always leaned on these groups to provide us with the initial input. In addition to large events, the District leads a few culturally relevant events by partnering with local organizations and schools.

- -Lunar New Year Celebration and Engagement session: Partnered with a school site at their parent and community event where local nonprofit partners provided resources and hosted a Lunar New Year celebration to celebrate the new year. The event also allowed families and nonprofit partners to share their input on our long term vision.
- -Black Community Event: A session located in a community center to welcome Black families, community leaders, and district staff to share their input on our vision and also listen to community leaders and staff panel share the importance of their voice to help build our long-term vision and strategic planning together.
- -Site specific engagement sessions: By training our Principals to host an engagement session at their school site allowed families and staff to share input and thoughts about our District in a familiar location and led by a leader in their school community.
- Guiding Coalition meetings: a team of 90 staff, community leaders, nonprofit partners, teachers, parents, and students gathered to review all the inputs from the various community engagement sessions to help draft and craft the long-term vision together.

As you will see in more detail in a subsequent section of this document, this year, engagement has looked differently than in the past. As a result of the visioning process, more voices from staff, community and students have emerged, with an emphasis on finding opportunities to meet where they are.

LBUSD hosted over 75 engagement sessions across Long Beach with all had translated materials in Spanish and Khmer in all events. Additionally, interpreters were provided in larger events and at specific educational partner meetings. Some of the sessions were led by students. Students part of the Guiding Coalition wanted to further engage their peers where students felt safer to share their thoughts with peers.

There is a concerted effort to engage more students than ever before. Going to school sites and engaging students in focus groups was the strategy to garner more student voice. In addition, students shared that they could engage with classmates and they also presented and received authentic feedback. We feel that student agency was at the forefront of much of the visioning and budgeting engagement process.

Prioritizing Mission Critical Initiatives

Staff has engaged in an intensive process to collaborate across leadership to elevate mission critical initiatives while valuing the many facets of central services. From over 70 distinct projects, seven mission critical initiatives emerged as focal areas to ensure students are central to decision making. Work streams are being created to describe the discrete actions of the initiative, as well as incorporate progress monitoring and benchmarking progress. These areas include the following:

- Black Student Achievement Initiative
- Creating Equity in Master Scheduling
- Supporting and Monitoring English Learner Progress
- Redefining Programs for Students with Disabilities

- Ensuring Quality Core Instruction in Every Classroom
- Developing Transformative Social Emotional Learning & Restorative Practices
- Developing Culturally Responsive Leaders

With the development of the strategic plan, there is cohesive alignment between these initiatives and the aspirations for LBUSD students.

Centering Black Students and Focus on Equity

"Equity in LBUSD means that we will take action to end systemic racism and discrimination that harms students because of their race, culture, disability, economic description, immigration status, gender identification, and/or sexual orientation. If LBUSD is acting upon this definition, then the descriptors listed above will not be predictors of success or failure in our system. Equity in LBUSD also means that we center the needs of our Black, Indigenous, People of Color (BIPOC) and students with disabilities within our efforts to deliver an excellent educational experience to all students." (LBUSD Policy 0415). This year, a priority for LBUSD will be to use its resources (financial, strategic and academic) to increase the academic achievement, social emotional well-being and post-secondary/life preparedness for Black/African American students. In addition to resources allocated through other initiatives, the Black Student Achievement Initiative has brought staff, students and community members together to develop innovations, engage Black families and initiate academic, enrichment and social emotional supports for Black students.

More specifically, the goals of the District include the centering of black students, as stated:

- -Goal 1 excerpt: The median student growth of Black students will be at least 25% greater than the previous year.
- -Goal 3 excerpt: Black student access to and success in A-G completion will increase at least 5%, beginning with the 9th grade cohort.

In addition to the district's goals, each elementary school principal has created an equity focus for their school, which includes progress measures for English Learners, Black students and Special Education students. At the Middle Schools & K-8 (MSK8) and high school levels, each school principal has a Black student progress monitoring goal. This focus on equity, and especially Black student achievement is being monitored at all LBUSD schools.

The strategic planning process led to a draft strategy for the system to, "employ a 'Targeted Universalism' approach to support Black students to reach universal goals of attaining the Graduate Portrait and develop a plan, co-constructed with our Black students and families, to identify and implement targeted supports for Black students." In this context, the term "Targeted Universalism" means setting universal goals, such as "all students attain the Graduate Portrait", and using targeted processes to achieve these goals. As LBUSD learns more about what works for different groups of students, for example, and builds success, we can also apply those learnings across the district, and build our capacity to support success for all students.

Some initial thoughts for activating this approach are:

- Center the needs of Black students to meet the needs of the whole child
- -Prioritize resources that promote social justice and attain equitable outcomes.
- -Monitor the impact of dedicated resources.
- -Create a dedicated staffing/team that includes Black staff.
- -Identify strategies that can be transferred and applied to the needs of other student groups
- -Responsibility to center/support Black students is not just for the dedicated team, but for all staff throughout the organization.
- -Targeted Universalism: We believe that introducing and socializing this language and concept will help with your framing of why, by centering Black students, we are learning what works for targeted groups and that EACH group deserves a targeted approach.
- -Add intersectionality of Black students and Special Education

Monitoring Progress through New Systems

Supporting English Learners

A new platform ("Ellevation"), designed to assist classroom teachers and school leaders in ensuring the success of English learners will be introduced to LBUSD teachers and leaders in the Fall. The Ellevation platform will assist classroom teachers, principals and district leaders in analyzing multiple sets of assessment data in order to make instructional decisions and set language development goals for English Learners. In addition, Ellevation supports integrated and designated instruction through materials and resources that support students' specific proficiency levels. The Ellevation platform tracks student progress toward English fluency and monitors students into and beyond the phase of redesignation. Teachers, principals and central office departments will have access to all English learner data as a means of collectively monitoring student acceleration, the interventions that are assigned to support students and their on-going progress toward academic success. In addition, a robust set of professional development modules will assist teachers in increasing their knowledge and capacity to support English learners in their language acquisition and content mastery through integrated and designated English Language Development (ELD). LBUSD has a renewed commitment to high quality ELD in secondary schools. With this renewed perspective, the staff spent this year planning for robust implementation in the fall 2023. A local review of ELD instructional materials for students in grades 6-12 began in Fall 2023 and recommended adoption of new instructional materials for Beginning ELD for both middle and high schools and Advanced ELD for high school. The Board of Education adopted the materials on May 3, 2023 for implementation in the Fall 2023. Professional development will be deployed to accompany the new adoptions. In addition, the Board of Education adopted three new ELD courses and one revised ELD course on June 7, 2023: Beginning ELD, Beginning ELD Workshop, Advanced ELD, and Advanced ELD Workshop. All of the

In Fall 2022, a committee was formed to begin a local search and review of Khmer world language for students in grades 6-12. The committee completed a thorough and structured evaluation process, considering social content compliance, alignment to the *World Languages Framework* and *Standards for California Public Schools*, and the quality of assessment and support for both teachers and students. The committee used structured evaluation tools to review for social content compliance, alignment to standards, and program evaluation and support. All of this has led to the adoption of four new Khmer textbooks for Khmer for Khmer Speakers courses. These textbooks were adopted by the Board of Education on June 7, 2023.

Also new for the Fall of 2023 and in support of LBUSD Newcomers, a new program will be implemented at four school sites, called "Enlace". It will serve as a hub for newcomers in middle school. The program is coordinated by the Multilingual office and will include 4 EL TOSA positions. This position will include a combination of course teaching and coaching and staff. Enlace will be located at 4 sites strategically selected around the city: Washington, Franklin, Hamilton and Marshall.

•iReady:

LBUSD has for years used an assessment system for reading and math progress monitoring using internal assessments. However, last year, LBUSD embarked on a new assessment system – iReady- in order to receive live results data to more quickly modify classroom instruction to the needs of the students. This system is nationally normed and used by hundreds of school districts. LBUSD also embraced a "accelerate, not remediate" posture. Results from iReady have been reported to the Board of Education more frequently as a part of the Board's Student Outcomes Centered agendas. Please see the next section for more detailed data from the mid year assessment.

Student Pulse Surveys

As a result of the needs of students coming from the pandemic years, there was a need to assess student social-emotional well-being more than the one time CORE survey, which has been used for a decade. LBUSD began this year to deploy a student pulse survey three times a year as a check-in about mental health needs. The survey takes about 10-minutes and contains questions about identity, belonging and agency, as well as inquiring if the student may need more immediate assistance. For students who need this assistance, the counselor at each school followed up with students individually to determine the needed support.

Here are some data points from the Fall administration of the pulse survey, which is given to students in grades 4-12:

-Elementary School results (over 7,600 responses):

Agency- 79% Favorable Responses. Agency is engagement and empowerment.

Belonging- 76% Favorable Responses. Belonging is acceptance and value by others without expectations of conformity.

Identity- 80% Favorable Responses. Identity is a strong sense of self.

-MSK8 School results (over 9,000 responses):

Agency- 77% Favorable Responses. Agency is engagement and empowerment.

Belonging- 72% Favorable Responses. Belonging is acceptance and value by others without expectations of conformity.

Identity- 80% Favorable Responses. Identity is a strong sense of self.

-High School results (over 14,000 responses):

Agency- 81% Favorable Responses. Agency is engagement and empowerment.

Belonging- 73% Favorable Responses. Belonging is acceptance and value by others without expectations of conformity.

Identity- 83% Favorable Responses. Identity is a strong sense of self.

As a result of the data, schools use the results to identify areas of strength and areas for improvement in order to meet the social-emotional needs of the students. Many schools use the data to engage student focus groups to generate ideas for improving sense of belonging at the school.

Student Focused Outcomes Board of Education Focus

Studying best practice in governance, the LBUSD Board of Education embarked on creating time at every Board meeting to analyze student outcomes. This practice requires time. So, the Board changed to a more consent-driven agenda, which allows for more time for staff reports that focus on student data, such as:

- -Literacy Interventions (K-5)
- -A-G Progress
- -LBUSD Workforce Diversity
- -Black Student Achievement: Programs, Processes and Engagement Efforts
- -iReady and SBAC
- -Supporting Multilingual Learners

Reflections: Identified Need

Social-Emotional Toll of the Pandemic

Even with the increased personnel with our students, we have received feedback to increase more personnel around teacher assistance, social workers, and nurses. LBUSD acknowledges that this is a result of welcoming students back to school after close to 2 years of distance learning and isolation for many students. Even with the implementation of the Wellness Centers and other SEL supports, it was clear students came back with much deeper challenges, including teachers engaging with some students developmentally 2 years behind academically and emotionally. This raised concerns to many teachers who might not have had all the proper tools to re-engage students who might have these developmental challenges and often out of their own expertise of their teaching. The beginning of the school year shifted the way we support our students both instructionally and emotionally. Together, as a district, we have challenged ourselves to support our students' academic growth and also social emotional supports to fit the current need of the student. LBUSD is committed to keep most of these services and supports in place to continue the process of supporting the whole child.

LBUSD recognizes that there is a need to embed more social-emotional learning into daily lessons, including the need to explore social fluency. The isolation of the pandemic has shown that students need more support. In addition, schools must acknowledge that social competence in some students has not seen appropriate growth and, as such, there is a need to create an environment that is complete with proactive and restorative tiered supportive practices. Building healthy connections and relationships with students is a continuing effort.

Academic Growth

The results of the state SBAC testing showed a drop in achievement in almost all areas. The data reaffirms the lasting effects of the pandemic on achievement and reminds us that the work of combating the learning loss is difficult. LBUSD did not see double digit drops as from the previous year, however we have not seen the gains anticipated. Our work with Quality Core Instruction and adoption of formative assessments deployed at the end of last year and augmented this year will hopefully make a difference. Here are some of the data points (also displayed in the Metrics section of Goal 3 in this LCAP) that are most concerning:

Percentage of students who meet or exceed standards in English Language Arts

• 48% All Students (-3%)

- 35% Economically Disadvantaged (-5%)
- 30% African Americans (-4%)
- 36% Hispanics (-8%)
- 12% English Learners (+5%)
- 16% Students with Disabilities (-9%)

Percentage of students who meet or exceed standards in Mathematics

- 33% All Students (-1%)
- 21% Economically Disadvantaged (-4%)
- 16% African Americans (-3%)
- 21% Hispanics (-6%)
- 10% English Learners (+3%)
- 11% Students with Disabilities (-2%)

English Learner Redesignation Rate:

The state has not released the data as of 6/10/23. However an internal source calculates an increase in Redesignation Rate from 2.4% in 2020-21 to 4.4% in 2021-22. Internal preliminary data has shown another increase in 2022-23.

LBUSD has had a system of formative assessments for years and it has been effective. However, the time it took to administer and receive results became prohibitive to make timely instructional decisions. In the 2021-22 school year, LBUSD implemented the iReady system for formative assessments. This has shown promise in terms of shifting to a focus on growth and acceleration, rather than remediation. Since it is an electronic platform, results for student skill reporting is virtually immediate. LBUSD teachers are learning how this data can inform differentiated instruction. In addition, parent reports throughout the year about their student's results are posted on ParentVue so that parents/guardians can have a sense of growth and targets.

Some encouraging results emerged from iReady mid-year data (2022-23):

- -64% of students in grades 1-5 are "On Track" for typical growth in Reading
- -52% of students in grades 6-8 are "On Track" for typical growth in Reading
- -58% of students in grades 1-5 are "On Track" for typical growth in Math
- -54% of students in grades 6-8 are "On Track" for typical growth in Math
- -47% of students in grades 1-5 who began the year as 1 or more year behind in Reading are "On Track" for meeting their stretch goal growth
- -36% of students in grades 6-8 who began the year as 1 or more year behind in Reading are "On Track" for meeting their stretch goal growth
- -40% of students in grades 1-5 who began the year as 1 or more year behind in Math are "On Track" for meeting their stretch goal growth
- -34% of students in grades 6-8 who began the year as 1 or more year behind in Math are "On Track" for meeting their stretch goal growth

Related, the new platform for spring and monitoring English Learner progress should prove as a difference maker for English Learners, including teacher training about how to embed academic activities in their lessons to increase student engagement for multilingual learners.

As LBUSD reflects on the summative results, we have recommitted ourselves to quality core instruction in all classrooms. Beginning in the summer of 2022, intensive training of all teachers commenced emphasizing a new "Understandings" continuum, which supports culturally responsive educators in using an asset-based approach to create equity-centered classrooms. There are six understandings, or agreements, that comprise Quality Core Instruction and are integral for creating equitable and inclusive learning environments. Moving forward with ensuring quality core instruction in all classrooms is at the heart of LBUSD's improvement efforts for student achievement.

The California School Dashboard reveals improvement needed in these categories: Chronic Absenteeism overall, Suspension Rate for Foster and African-American children and English Learner Graduation Rate. LBUSD acknowledges chronic absenteeism concerns. There is a connection between absenteeism and the lingering effects of the pandemic. In addition, foster and African-American youth are suspended at higher rates than other students. Suspensions are a topic that our school sites have reviewed and there is a need to help schools understand other means of correction in an equitable way. A strategy that directly impacts suspensions relates to restorative practices (Acton 2.4) that are a key initiative of LBUSD. This work has shown promise and is being extended to more schools, where intensive staff training is key to understanding the issue and how to respond. In addition, the Los Angeles Office of Education's (LACOE) PBIS training and philosophy has proven to make a positive difference at the elementary level. LACOE, through its Differentiated Assistance technical support, and the LBUSD Office of Student Support Services have collaborated in analyzing root causes, including looking deeper into teacher recruitment (including recruiting more Black staff), culturally responsive practices, and tools for educators to use to provide supportive means of correction. In this LCAP, as well as overwhelming demand from partners, the many investments in social-emotional/mental health supports, including that of Action 4.1, should help mitigate suspension and absentee data. In addition, Action 3.13 engages families of African-American youth to continue to generate services and activities that bolster sense of belonging and identity, which correlates to better attendance and engagement.

The graduation rate of English Learners is lower than other students. LBUSD has completed a thorough audit of its ELD offerings. The findings showed that more ELD courses are necessary at the secondary level. For the 2023-24 school year, more ELD courses will be added. In May, the Board of Education approved new instructional materials for Secondary Beginning ELD and High School Advanced ELD- a commitment to ensuring English Learners receive the most updated and research-based programs to support their pursuit of redesignation, as well as improve the graduation rate of EL students (primarily Action 3.7).

In addition, as mentioned above, staff engaged in an intensive process to collaborate across leadership to elevate mission critical initiatives, which puts into focus the work needed to support our most struggling students in an equitable system. Leadership in these areas will help increase student achievement. These priorities include:

- Black Student Achievement Initiative
- Creating Equity in Master Scheduling
- Supporting and Monitoring English Learner Progress
- Redefining Programs for Students with Disabilities

- Ensuring Quality Core Instruction in Every Classroom
- Developing Transformative Social Emotional Learning & Restorative Practices
- Developing Culturally Responsive Leaders

LCAP Highlights

A brief overview of the LCAP, including any key features that should be emphasized.

Equity

LBUSD has embarked in a historic and important journey in examination of our total system with an eye toward equity. The Board of Education approved a new policy, Board Policy 0415-Equity and Excellence in 2021, which continues to be central to all efforts in LBUSD. While the mission of LBUSD is to provide a high quality education for all children, this policy will center the experience of BIPOC (Black, Indigenous, and people of color) and children with disabilities to ensure that groups that have been historically discriminated against by white supremacist laws and systems will be uplifted.

Numerous equity initiatives drive the actions and services in the LCAP. Specifically, the goals of the social-emotional learning initiative are to promote understanding, examine biases, build cross-cultural relationships, and cultivate adult and student practices that close opportunity gaps and create more inclusive school communities. Moreover, from the standpoint of academic growth, the learning acceleration, support, and enrichment initiative focuses on the development of intervention models for literacy and math as well as other extended learning opportunities.

LCAP - Continuing to address pandemic's effects

It is of note that many of the actions that were listed in last year's LCAP were also priorities from this year's engagement activities. Much of the landscape that existed as a result of the pandemic continues to be of concern to the community and LBUSD staff, including the profound academic and mental health effects on students from school closures. Mental health of students as they reintegrate into the school has been an ongoing discussion of parents, community and staff. In response to provide continuity and quality of services as we continue to support students with the pandemic's effects on education and mental health, this edition of the LCAP has similar actions as last year's edition.

Continuing Key Programs

Several key programs and services will continue to be budgeted from last year's LCAP, especially in light of the ongoing effects of the pandemic, especially mental health and learning loss. Among other programs, LBUSD is planning to continue the following key line items:

Expansion of Wellness Centers

At the beginning of the last school year, LBUSD opened a wellness center at each of its 11 high school sites. The center offered a space for students to drop-in to do a wellness check, engage with a dedicated wellness counselor for deeper intervention and support, and access food to eat at school or take home through their food pantry. On average, 482 individual counseling sessions were given each month, with a total of over 62,000 walk-ins. Other services included individual family/caregiver meetings, individual staff consultations, student presentations and student group presentations, caregiver presentation, and management of referrals from staff and the broader community. The social workers placed in every wellness center engaged with students on a wide range of topics and created a safe space for students to address their mental health needs.

As a result of the positive and overwhelming response from students, staff and community, this year, LBUSD expanded the program into all middle and K-8 school sites. Much of the same data in terms of student use again points to the need for mental health services for students, as we continue to fight against the adverse effects of the pandemic, The middle and K-8 school Wellness Centers have a similar design to its high schools, however services are determined with a focus on age appropriateness, In addition, our high school Wellness Centers have worked to refine their services in response to the needs of students.

The use of the Centers continues to be high with current year data as follows (2022-23: September through February):

High School:

Over 2500 counseling check-ins

Over 2000 individual counseling sessions

Over 800 group counseling sessions and workshops

Middle School:

Over 4000 counseling check-ins;

Over 2500 individual counseling sessions

Over 1500 group counseling sessions and workshops

• Additional Counselors and Social Workers: As part of LBUSD's holistic approach to wellness, counselors play a pivotal role in coordinating social-emotional supports and mental health referrals for families. They are available to support families at every school site, but the aspect of their work that contributes to increased and improved services for unduplicated pupils concerns specific connections with disengaged families who are experiencing trauma like never before. This process includes more personalized and targeted support for low-income families, English learners, and foster youth who are otherwise unresponsive to traditional means of communication. It also involves more specialized coordination with the School-Based Mental Health Collaborative and other community partners due to their socioeconomic challenges, language barriers, and unstable home environments.

In fact, when looking at a holistic view of support to students, LBUSD's ratio of mental health provider staffing has seen dramatic decreases in provider to student ratio, which is a testament to meeting the needs of students in this area. For the 2022-23 school year, the mental health provider to student ratio is 280:1, as a result of an increase in 70 FTEs since 2020, including Counselor, Psychologist, and School Social Workers. Here is a chart of data related to mental health provider ratios:

- Literacy Coaches: The Elementary Literacy Coach trains and supports literacy teachers at high needs Elementary and K-8 schools. The coach supports the implementation of the Leveled Literacy Intervention and WonderWorks intervention programs through curriculum design/ development; program implementation; and professional development, including coaching. The work of the coaches helps to strengthen the quality of classroom instruction, and they supplement many other professional development opportunities funded by different federal, state, and foundation sources. Literacy coaches brought a high degree of instructional expertise directly to schools, whereby coaching and professional development were enhanced as a result.
- Restorative Justice: LBUSD established a partnership with California Conference on Equity and Justice to support virtual RJ training focusing on restorative dialogue, circle processes and community-building activities. A guide to support the use of Restorative and Safe & Civil practices in building a safe, welcoming and inclusive school culture was developed. The year was filled with opportunities to build a strong foundation around restorative practices in schools, and increase staff capacity to provide support on the site level towards quality implementation and focus on both the school community and specialized support for our students.

Local Control

Note that, in the spirit of local control and accountability, there are many services that are determined at the school level. Sites have the flexibility to construct plans – with approval from the School Site Council — that address the unique needs of their students. LCFF funds are allocated to school sites in order to meet the needs of their students. Each school has unique needs and allocating LCFF funds directly to schools assists them to determine programs and services that can make positive gains for students. Although not legally required to do so, the School Plans for Student Achievement (SPSA) lists the proposed expenditures of the site allocated LCFF funds. These plans are expected to align with the State Priority Areas, LBUSD equity initiatives, and other local efforts. Furthermore, other resources, particularly Title I federal funds, are used to supplement base programs. Although the LCAP does not specifically itemize these expenditures, it is important to highlight the many different ways that services are provided to students in need. More specifically, Action 3.10 in the LCAP addresses this important highlight. Needs assessments written within each site's SPSA dictates the proposed expenditures to emphasize the needs of English Learners, low-income pupils and foster youth to close opportunity and achievement gaps. In addition, for the

2023-24 School Year, in response to community engagement, an enhancement in enrichment activities will be a budgeted allocation to all elementary and K-8 schools specifically for field experiences. With a lens toward equity, many unduplicated elementary students do not have real-world, field experiences that help make connections with concepts learned in the classroom.

Learning Acceleration and Support Plan 2.0

LBUSD has created a second version of the Learning Acceleration and Support Plan (LASP) which attempts to show the braiding of resources, especially in light of the various COVID-19 relief funds. The school district began this planning based upon students' needs, blending together various resources – including significant and newly available pandemic recovery funding from the state and federal governments – to provide the best possible learning opportunities and related support. The LASP focuses on four "pillars":

-Pillar I: Academic Acceleration and Support

-Pillar II: Social-Emotional Well-Being

-Pillar III: Engagement and Voice

-Pillar IV: Infrastructure and Capital for the Future

Within each pillar there are several line-itemed programs, funding sources, department leads, and the mission critical initiative that the line item purports to address. The LASP is an important part of the overall LBUSD budget and engagement with the community. When looking at the budget in its entirety, LBUSD emphasizes the need for input for programs and services that meet the needs of students. Programs and services mentioned in community input were reviewed and considered for inclusion in the LCAP or other resources. The LASP can be found at lbschools.net/LASP.

Comprehensive Support and Improvement

Support for Identified Schools

A description of how the LEA has or will support its eligible schools in developing comprehensive support and improvement plans.

Support for schools is grounded in coaching and professional learning communities. LBUSD has shifted from compliance and at-a-distance supervision practices to a deeply rooted coaching orientation, partnership in addressing student achievement issues, and a strong emphasis on quality instruction in every classroom, as defined by the district's Understandings Continuum framework. Since 2014, LBUSD has sought to enhance time spent on campuses, with leaders dedicating an average of three to five hours per month on every campus – visits that include classroom observations alongside the principal, data collection related to instructional implementation, and pedagogical guidance for teachers. Comprehensive Support and Improvement (CSI) schools receive even more intense support, particularly in areas like English Language Arts, Mathematics, and graduation rates.

One crucial area of support centers on school-level needs assessments. LBUSD's Research Office provides in-depth data tailored to each site, which are then used to develop interventions in consultation with educational partners. Academic measures include ELA and Math benchmarks, real-time grades (especially Ds and Fs), and whether students are on track to complete graduation requirements, while non-academic measures cover chronic absenteeism, suspensions, and disciplinary incidents. With assistance from district leaders, curriculum coaches, and other experts, CSI schools drill down by academic skill, by student group, and by logistical factors (e.g., the time of day and location of suspensions). Site staff receive tools and training to create "watch lists" – i.e., lists of classrooms to monitor closely and lists of students who require further interventions. The latter is connected to phone, email, and text communication systems that can help engage families in the process.

Here are specific supports that LBUSD delivered (and will continue to provide moving forward) to help CSI schools develop their plans:

- -Level office staff spent additional hours at CSI schools to help their principals conduct deeper analyses on chronic absenteeism, suspensions, disciplinary incidents, and survey data related to school culture and climate and social-emotional learning. Such analyses were on top of those conducted for academic measures like English Language Arts, Mathematics, and graduation rates.
- -Level office staff, curriculum leaders, and other district support departments provided CSI schools with research on successful evidence-based interventions in comparable schools, both at LBUSD and other districts in California. Depending on the programs, the research included either academic studies or best practices. This information was paired with budget information so that programs can be sustainably developed
- -Level office staff, curriculum leaders, and other district support departments assisted CSI schools with identifying resource inequities by providing reports on current staff levels, budget figures, and logistical data. Through various one-on-one meetings, sites were then guided by content experts in identifying significant resource gaps. For

example, a review of a site's English Learner supports would incorporate additional teachers that might be needed, along with the instructional materials, technological software, intervention scheduling design, and other details that would help build out the program.

- -Based on the research and "gap" analyses described in the two previous bullet points, level office staff, curriculum leaders, and other district support departments helped CSI schools select evidence-based interventions. Among the guiding principles that LBUSD promoted in this decision-making process is sustainability the importance of developing high-impact programs that can be implemented in multi-year timeframes. Given the depth of student needs, it was essential to have a long-term perspective and make adjustments along the way. LBUSD then ensured that CSI schools had training for program implementation.
- -Lastly, level office staff, curriculum leaders, and other district support departments helped CSI schools establish monitoring and evaluation systems. Supports included training on how to identify appropriate data to collect (for example, student participation in interventions, related test scores, etc.), how to use LBUSD's "intervention tracker" or similar system, how to schedule data analyses alongside the site visits described above, and how to use feedback for program improvement. In some cases, LBUSD provided CSI schools with sample survey questions for gathering student, parent, and staff perspectives. LBUSD also paired CSI schools with similar partner sites so that data can be compared and promising practices can be shared.

Monitoring and Evaluating Effectiveness

A description of how the LEA will monitor and evaluate the plan to support student and school improvement.

To monitor and evaluate the effectiveness of the CSI plans, quarterly visits will be conducted. These formal visitations will allow site teams to reflect upon their collective efforts and engage colleagues from other schools and district departments for objective feedback. The monitoring and evaluation activities will be conducted in-person following appropriate public-health guidelines.

Quarterly visits will be customized by schools, but follow a common structure:

Whole Group Briefing: The school team (principal, teachers, and support staff) will provide background for the visit by sharing their CSI plans. They will highlight their site data, professional development activities, and key interventions. They will help visitors (Level office staff, curriculum leaders, and other district support departments) develop an understanding of their priorities.

Classroom Visits: School team members and visitors (Level office staff, curriculum leaders, and other district support departments) will observe classrooms, collecting data and examples that reinforce the school's CSI plans. They will take notes, collect images, and talk to students in order to summarize their observations.

Whole Group Debriefing: School team members will facilitate a debriefing that allows them to understand and affirm the site's continuous improvement efforts. They will focus not only on content delivery, teaching practices, and student actions, but also the various interventions that are being implemented to support struggling learners.

Principal Debriefing: Principals and/or principal supervisors will engage in further discussion regarding next steps. This dialogue will be folded into the regular coaching work described in the previous section.

More broadly, the LROIX platform developed by LBUSD's Research Office features tools that allow district and site leaders to monitor the progress of CSI schools and their students. LROIX functions enable district & site administrators and teachers to track students who are "at-promise" across a broad spectrum of measures, including chronic absenteeism, discipline, course grades, graduation requirements, iReady growth, and high school or college readiness (as applicable). Such real-time data will be used to adjust CSI plans and develop additional interventions for struggling learners.

Educational Partners

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

Budget Engagement Process

LBUSD seeks input from its educational partners in a larger process to engage with multiple budgets to accurately pinpoint programs and services that meet the needs of students. This allows for ways to compliantly braid funds to ensure that needs are met using a variety of resources, especially in light of the one-time nature of pandemic relief funding..

The LCAP anchors the entire LBUSD budget as this provides the foundation of funding of the district's base program. In addition, the concentration and supplemental grants (additional parts of the LCFF that are based on unduplicated pupils (EL, Low SES, and Foster Youth) provide for programs and services that are intended to meet the needs of the unduplicated pupils. In the budget planning of other resources, such as ESSER and other one-time funding sources, the LCAP continues to provide the foundation of the budget, while the other resources provide programs and services that augment or supplement the LCAP. The coordination of all these resources through the budget engagement process prevents stand alone/one-time services that are not sustainable.

The following paragraphs provide a timeline of engagement activities, including highlighting some past efforts because LBUSD has embraced an ongoing budget engagement process that includes important context from an ongoing pandemic, which the effects on students continue to be a major factor in the input of educational partners.

Original Questions

During the 2020-21 school year, LBUSD employed a strategy that has found success by engaging the community through a budget engagement process so that the responses can inform multiple resources- categorical, COVID assistance, LCAP, etc. This approach takes a holistic approach to budgeting. LBUSD's community engagement process focused on three guiding questions and a follow-up question:

- -What practices would be most effective in addressing academic support?
- -What practices would be most effective in addressing social-emotional learning?
- -What practices would be most effective in addressing student engagement and motivation?
- -What other ideas do we need to consider? What is missing from the draft LCAP?

The district received close to 2,000 responses and 57,000 ratings from nearly 3,500 participants.

Last Year's Engagement

In October 2021, LBUSD deployed a new ThoughtExchange© seeking responses about how to best support the needs of current and future students. As part of the budget engagement process, LBUSD asked for priorities on how to spend LCFF, Title I, state and federal relief funds including the recent ESSER III funds, Participation included 453 participants, 576 discrete thoughts and 11,549 ratings. Throughout the ThoughtExchange© and parent/community group meetings, there were consistent themes that emerged in the Academic Support strand, including Academic Interventions, Literacy Interventions and reduction of class sizes, which has influenced the LCAP as well as other resources.

Beginning in February 2022, the Budget Engagement Process continued with a new ThoughtExchange© extending the same themes as in previous years. The question asked was:

As we continue to implement programs and supports identified in the LCAP, Learning Acceleration and Support Plan (LASP), and the Elementary and Secondary School Emergency Relief Plan (ESSER III), what are additional supports that need to be considered? Please take into consideration that certain funds, including Title I and LCFF Supplemental and Concentration funds, require targeted supports for our highest need students or schools.

The final results of the ThoughtExchange © gave LBUSD impressive numbers, especially the student input. The use of this platform, along with the engagement of LBUSD parent groups and in-person connection with students provided the input that was needed in order to support the actions that are present in the LCAP. There was an overwhelming desire to ensure continuation of many of the mental health supports that were in place last year, as the pandemic continues to have an impact on students and the greater community. There were a total of 2,352 participants, initiating 2,319 thoughts and 54,852 ratings. Three themes emerged from the engagement:

- -Budget Priority 1: Staffing and Staff Training
- -Budget Priority 2: Foreign Language and other electives
- -Budget Priority 3: Mental Health Programs

2022-23 Engagement

During the 2022-2023 school year, LBUSD, in collaboration with our partners at Prospect Studios, worked on developing a long-term vision and strategic plan for what we want our school district to become by 2035. Through the development of Vision 2035 and the strategic planning process, the community was invited to participate in multiple sessions and spaces which provided a continued understanding of stakeholder priorities and deepened our engagement with the community. These opportunities were granted through a series of three iterations: Oct-Nov 2022 (Input phase), Jan-Feb 2023 (Feedback phase), Spring 2023 (Final feedback phase) with outreach that included students, families, teachers and staff, and community representatives.

The process was through an equity-design lens. This iterative process allowed every member participating to be part of working together to understand what problem we are trying to solve and sharing their hopes and aspirations for our students and district into the future. It was through this back-and-forth process- check-in with each other where we are, see if we are accurately understanding the community's feedback, and re-engaging to refine our vision- which allowed us to build deeper relationships with one another. The vision will allow staff to put together a strategic plan aligned with our long-term goal.

As we developed the LCAP, we center the voices lifted during the Vision 2035 process that consisted of a graduate, adult, and system portrait, reflecting short and long-term goals- and aligning actions to a new strategic plan. During the process, the refinement of each portrait was a result of valued community input where we asked "did we get it right" and our community lent its voice by seeking clarification and refining aspirations through robust engagement.

The following events helped to ensure the engagement and feedback loop continued throughout the process. In between the engagement sessions, a team of 90 members from community, staff (including leadership of our labor partners), students, and families were a part of putting together the community feedback into our vision statements. Each session, including all three Guiding Coalition sessions, had Spanish interpreters available for community members. Spanish interpreters were also made available for students during the two Student Summit sessions held at Long Beach City College. All of the sessions had Spanish and Khmer language translation available for all materials shared.

Student Summit: September 28 - 30, 2022

The visioning process started with a student summit. Every middle, K8, and high school brought at least 20 representatives to share their experiences at LBUSD and also their hopes and aspirations for each other and adults in our system. With over 750 students participating, it was a big event filled with student input and stories. By asking students to share a story about an adult who made a difference in their lives, we gathered qualities of adults we would like the adults in LBUSD to be able to gain to best support our students.

Learning Journeys - September - October 2022

The purpose of learning journeys is to provide opportunities to step outside our daily context and be introduced to innovative and future-focused educational models. These journeys are intended to inspire some new thinking and prompt ideas or questions you can bring with you as we began drafting our Long Beach Unified vision. These journeys had one in-person visit, live virtual visits and self-paced virtual microsites, as listed below:



Guiding Coalition #1: October 14-15, 2022

Through hosting static displays in various administrative offices, hosting four zoom sessions, a survey, in-person engagement sessions with DELAC, EONA, PIEV, DCAC, OCIPD staff, Century Villages at Cabrillo, Sankofa Parent Village, and in middle school classes, we gathered over 13,000 thoughts during this phase.

Guiding Coalition #2: December 2-3, 2022

Through the 2nd guiding coalition, we came together with initial vision statements and key themes for each portrait. We went back to the community to ask them what they thought and asked them to rank their top 6 choices. There were 58 engagement sessions during phase two, as shown by the map below. To meet where the families and staff live in the city, we leaned on our Principals to lead engagement sessions.



Guiding Coalition #3: February 24-25, 2023

In the final Guiding Coalition meeting, we were able to produce our core values. Some key lessons learned through our engagement process this year is the value in ensuring language access, providing ample opportunities to give feedback, center our community, and leveraging school sites as the hub for engagement. FOr the future, we need to spend more time with staff to be able to feel more comfortable with engagement and also building systems in place to have more coherence in how often we engage with our families.

Community Installation - April 20 & 22, 2023

The final journey with the public around Vision 2035. The public was allowed to review the "almost final" Vision and provide one last opportunity for comment and feedback. For those unable to attend, a survey was posted on our website and shared. Through the final community installation process, the team received feedback on how they can improve the language for public consumption. It was important for the public to feel that their fingerprints can be found in the final Vision 2035.

Moving forward, this year's engagement will support the community engagement team to build a framework for community engagement for the District and school sites to adopt. It will be one of the key priorities the District will adopt for the 2023-24 school year.

Parent Groups

As part of the commitment to engage with LBUSD parent groups and the elected Board of Education, staff has continued to keep the budget engagement process at top of mind. For the parent groups- District Community Advisory Committee (DCAC) and District English Learner Advisory Committee (DELAC)- staff worked in three phases:

During each phase, community members receive information and provide valuable feedback during the construction of the overall budget of LBUSD, including the LCAP. During Phase 1, the "budget pyramid", a representation of LBUSD's entire budget, which includes local, state and federal revenues, was shared. As explained during parent group meetings, the LCFF funds form the foundation of the pyramid and the LCAP is the plan that includes each proposed program and service and budget allotted. It is also emphasized that the Learning Acceleration and Support Plan (LASP) shares almost all of the local, state and federal budget- including some LCFF programs- in an easy to read document, also featuring programs and services and their budgets. The LASP can be found at www.lbschools.net/LASP.

Phase 2 highlights the manner in which community and student voice is incorporated into various budgeted programs, indeed including the LCAP. Phase 2 showed the three-pronged alignment between 2 years' worth of community engagement/input, district goals, and budgeted programs and services. For example, one of the strongest themes from both 2022 and 2023 engagement was to provide social-emotional support for students. In fact, a district goal and mission critical initiative assert mental health supports are critical for student well-being and achievement. The connection to the LCAP shows direct alignment with the community input and district goal/initiative through Action 5.3 where Middle and High School Wellness Centers is budgeted. The Wellness Centers provide direct support to students. As stated in this document, over 6500 check-ins with students have occurred during the first semester. Also during Phase 2 is the crafting of the first draft of the LCAP, which was posted on May 3, 2023.

Phase 3 is an opportunity to continue to engage with the community and refine the draft LCAP, which will become the recommended LCAP for Board approval.

Draft LCAP Posted and Presented

On May 3, 2023, the first draft of the LCAP was posted along with a community feedback opportunity. The draft was presented to DCAC on May 25, 2023 and to DELAC on May 8, 2023. Opportunities for questions and comments were given in the form of a ThoughtExchange. The Thought Exchange was a part of the May 3rd Board meeting presentation and was sent via School Messenger to families. In addition, a large poster with a QR code that links directly to the ThoughtExchange was posted in the front of each district school.

The ThoughtExchange provided for two opportunities: (1) Provide input and rate thoughts with the following question:

"Through past engagement opportunities, the LBUSD community voiced social-emotional well-being, enrichment, and tutoring as top priorities. To assist us in planning next year, what specifically can we do to continue to improve your child's experience in these areas?"

The second part of the ThoughtExchange gave an open-ended opportunity to ask questions about the Draft LCAP: "Do you have any questions about the draft LCAP?". The responses to this question, along with the questions and comments at the in-person meetings are the foundation for the written report from the Superintendent. The Superintendent will post the written report on the LCAP webpage (www/lbschools.net/LCAP). The report will be emailed to the rosters of DCAC and DELAC. On May 22, 2023, a second draft of the LCAP was posted and the ThoughtExchange continued to be open and available for public comment. On June 2, 2023, a third draft of the LCAP was posted in preparation for the Public Hearing, scheduled for June 7. For each posting of the drafts, a summary of the major revisions were posted to promote transparency.

Board of Education Continuous Updates and Recommendation for Approval

As described in this section, budget engagement is an ongoing and interactive process, with a lot of information sharing, listening, analysis, revisiting, and continuous dialogue with broad educational partner groups. Updating the Board of Education about the budget development, including the LCAP, was very important throughout the process. In fact, at most every Board meeting from February 2023 through June 2023, a staff report was presented to update the Board and general public about the progress of the educational partner engagement and the development of the LCAP. For the LCAP, the culmination is a recommendation for approval at the June 28, 2023 Board of Education meeting, with a Public Hearing that was held at the June 7th Board Meeting.

They shared their experiences and voiced their concerns that helped us re-think how we engage with them. It also reminded us about our commitment to center our discussions with student need at the forefront of our work.

A summary of the feedback provided by specific educational partners.

As noted above, LBUSD has utilized a variety of engagement approaches in the past three years to engage the community and garner valuable feedback. The last few years have focused on partners sharing their thoughts on programs and services that would benefit students with the idea that the overall budget is more than the LCAP

and that programs and services could be funded by various resources, including LCFF. More specifically, the feedback from LBUSD's educational partners were themed into three priority areas, as described below:

Budget Priority 1: Staffing and Staff Training:

-Literacy Specialists; Nurse Services; Counseling Services; SEL/School Climate Support; Elementary Teacher Assistants; Primary Language Support; Small Group Instruction; and Diversity in Staff

Budget Priority 2: Foreign Language and Other Electives:

-More elective courses, including different languages; Ethnic Studies, including Khmer history; Bilingual Education/Realistic and Relevant Curriculum; Teacher Pipeline Programs/Diverse Workforce

Budget Priority 3: Mental Health Programs:

-Mental Health Personnel (Counselors, Psychologists, Social Workers), including diversity in personnel; Tools for classrooms to process anxiety, suicide and support emotional growth; Engage and empower youth with tools around bullying (including sexual violence) and positive relationships; More learning on health and social emotional learning

Armed with last year's engagement data, this year LBUSD took a more aspirational position to engagement. Utilizing a new approach under strategic planning and visioning, three portraits were created with a multitude of feedback from educational partners, including students who used a tremendous amount of agency to conduct student-led forums. These portraits were developed as part of the visioning process from many hours of community engagement. There are three portraits: (1) Graduate Portrait, (2) Adult Portrait and (3) System Portrait. The Graduate Portrait is the centerpiece that guides everything else—what do we want students to know, be, and be able to do so that they can thrive in their lives and careers in the future. The Adult Portrait came from the question, if we want students to know, be, and be able to do certain things, what do the adults supporting them in the school district need? And if adults are being asked to do different things, how does the system need to change to support them so that they can support all students to attain the Graduate Portrait? This leads to the System Portrait. The following is the 'near final' version of each Portrait:

Graduate Portrait Themes

What do we want students to know, be, and be able to do so that they can thrive in their lives and careers in the future.

- -Equity Inclusion Leader- Students view diversities as assets to our inclusive community, understand the historical roots of racial and cultural bias that have led to institutional practices of oppression, and know how to act in ways that promote equity and inclusion.
- -Future-Ready Adult- Students are prepared for their futures with essential life skills, are connected to a network of allies, and have a direction and plan after completion of high school.
- -Trustworthy and Respectful Human Being- Students are responsible, trustworthy and empathetic and practice respectful behavior toward others and our environment, both in person and digitally.
- -Resilient, Thriving and Mindful Self-Advocate- Students express self-confidence in how they positively honor their identities and how they advocate for their needs. They are mentally and physically resilient, know how to manage stress and work toward a balanced lifestyle.
- -Adaptable, Lifelong Scholar- Students see learning as a lifelong endeavor that enables them to pursue their passions and interests and know how to apply foundational academic knowledge integrated across various disciplines to develop new understandings.
- -Ethical Problem Solver- Students know how to apply different thinking, research, and problem solving methods to develop creative solutions that address the needs of people for whom the solution is intended.
- -Informed Global Steward and Communicator- Students demonstrate key global competencies needed to productively participate in our connected, worldwide community and act on issues of global and local significance.
- -Interdependent Collaborator- Students value collaborating in diverse teams and know how to leverage the collective genius of their team members to maximize productivity and reach outcomes.

Adult Portrait Themes

If we want students to know, be, and be able to do certain things, what do the adults supporting them in the school district need?

- -Equity Focused Change Agents- Adults champion diversity, equity and inclusion by modeling cultural awareness and engaging in ongoing self-reflection.
- -Positive, Resilient, Health Professional- Adults are self-aware, confident and passionate about their work. They are knowledgeable about mental health so they can best care for themselves and others.
- -Adaptable and Reflective Lifelong Learner- Adults are open-minded and committed to ongoing learning to continue developing as professionals and to adapt to a changing world.
- -Empathetic Communicator- Adults communicate across cultures clearly, openly and honestly in a way that shows care and concern for students, families, and staff.
- -Empowering Facilitator of Learning- Adults provide engaging, relevant learning experiences to support learners' needs, build on their strengths, affirm their identities, and encourage their growth.
- -Critical and Creative Thinker- Adults are flexible, innovative, and solutions-oriented systems thinkers who can think creatively to solve problems.
- -Community-minded and Collaborative Leader- Adults build strong relationships with peers and the community, and they collaborate both locally and globally to catalyze change and reach common goals.
- -Champion for Students- Adults support and encourage students in their goals, empowering them to take risks and grow.

System Portrait Themes

If adults are being asked to do different things, how does the system need to change to support them so that they can support all students to attain the Graduate Portrait?

- -Equitable System- LBUSD is an equitable system: we acknowledge harm, and use restorative¹ practices to heal; we use liberatory mindsets and practices to reimagine inequitable processes and structures; and we base our equitable allocation of resources on students' needs.
- -Flexible, High-quality Learning with Real World Application- Every LBUSD student is supported to develop their sense of agency and reach their full potential through flexible, forward-looking, learning experiences with real-world application.
- -Open District: Family, Community and City Collaboration- LBUSD is committed to working in partnership with our families, our community, and our city government, and we develop the systems and structures needed to build trust, listen deeply, craft shared goals, and collaborate to attain them.
- -Global Competence and Connection- LBUSD values Long Beach's rich cultural diversity and global connections. We support our students and staff in developing awareness and appreciation through support for multilingualism and international programs.
- -Culture of Inclusion, Well-being and Affirmation- LBUSD intentionally develops an affirming, asset-based culture in which every student, family member, staff member and community member feels a sense of welcome and belonging.
- -Culture of Equity-centered Innovation and Creativity- LBUSD's system-wide innovation practice builds the agency of students and staff to collaborate in diverse groups, think creatively about challenges, and to learn forwards by prototyping solutions.
- -Future-focused Facilities and Technology Infrastructure- We are proactive in the planning, design, and maintenance of our facilities, and our technology infrastructure. We plan for climate resilience so that we can create future-ready physical and virtual environments while managing cost.

These aspirations for students, adults and the LBUSD system require planning and, in some instances, rethinking of resource allocation. Looking at this aspirational work in conjunction with the programs and services feedback create a more holistic view for today and tomorrow. The connection between the feedback (portraits and programs) gives a sense of direction to what students need now, as well as what students, adults and the district needs to plan for the future, including resource allocation.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

For the past several years, LBUSD has emphasized input in the form of recommended programs and services to help with the coordination of an overall budget. There are many separate funding streams that comprise the overall district budget, such as LCFF, ELO, ESSER I, II, and III. The focus of LBUSD's budget engagement process was to uplift programs and services that meet student needs. Suggested programs and services from the community allowed LBUSD to determine a specific fund to use for a chosen program- so long as the program is allowable under the regulations of a particular resource. This strategy has allowed LBUSD to map out a cohesive, multi-year budget plan rather than several distinct plans that may not emphasize student need, nor prevent stand-alone projects that are unsustainable.

It is of note that many of the actions that were listed in last year's LCAP were also priorities from this year's engagement activities. Much of the landscape that existed as a result of the pandemic continues to be of concern to the community, including the profound academic and mental health effects on students from school closures. Mental health of students as they reintegrate into the school has been an ongoing discussion of parents and staff.

The aspirational Portraits, as described above, are a result of many hours of collaboration with educational partners. These portrait themes connect with the actions of the LCAP. More specifically, here are some examples of the alignment/connection between the Graduate Portrait and the LCAP:

- -Equity Inclusion Leader- Students view diversities as assets to our inclusive community, understand the historical roots of racial and cultural bias that have led to institutional practices of oppression, and know how to act in ways that promote equity and inclusion. LCAP Action 3.13- Black Student Achievement Initiative and Action 2.4- Restorative Justice promote culturally relevant and inclusivity.
- -Future-Ready Adult- Students are prepared for their futures with essential life skills, are connected to a network of allies, and have a direction and plan after completion of high school. Goal 3, supported by its actions, assert that, "Students will make academic progress... so they can be prepared for both college and careers upon high school graduation. In addition, Action 4.2 expands college and career readiness efforts.
- -Resilient, Thriving and Mindful Self-Advocate- Students express self-confidence in how they positively honor their identities and how they advocate for their needs. They are mentally and physically resilient, know how to manage stress and work toward a balanced lifestyle. Action 2.2 promotes student agency, identity and belonging. -Interdependent Collaborator- Students value collaborating in diverse teams and know how to leverage the collective genius of their team members to maximize productivity and reach outcomes. Again, looking at Action 2.2, student advisories are active in their schools and take the student experience- both good and bad- to adults to advocate for change.

The Adult and Systems portraits support the Graduate portrait. The need for change is evident by the aspirational themes of the Graduate Portrait. If we want students to exemplify the attributes of the Graduate Portrait, the Adults need to have the skills and the System needs to develop the skills of the adults so they can support the attributes of the students. That said, personnel, which is 75% of LBUSD's total budget, is the majority of Actions 1.1, 1.2, 1.3. Teachers are in action 3.1 and are the most important factor in student achievement. Librarians and Library Media Assistants, Counselors, Psychologists, Administrators, Intervention Teachers, Coaches, Music Teachers, and other personnel appear in the LCAP. The Adult Portrait attributes will be important in supporting the highly critical and aspirational Graduate Portrait. LBUSD is continuing the work to develop a strategic plan that will align these portraits with strategies and alignment with the LCAP is key.

Representatives from CAC and the SELPA took a leading role in the development of an Adult Portrait theme and two System Portrait themes. More specifically, the Empowering Facilitator of Learning in the Adult Portrait, has a key strategy that states, "[Adults in LBUSD] are knowledgeable about how students and adults learn and develop in different contexts. They understand individual learners' needs and assets and how they intersect (e.g. students receiving special education services, English Language Learners), and use data to adapt teaching methods to meet those individual needs, enabling equitable access and inclusion for all learners. They provide appropriate scaffolding to increase access and support for all learners to meet the rigor of the standards, and provide ongoing feedback cycles and ways for learners to monitor their growth." In addition, these same representatives helped develop two System Portrait Themes that specifically address students with disabilities- Equitable System focused on Excellence for All ("In our pursuit of excellence for all, we bring in the voices of those most impacted, especially students, to inform our decisions. We allocate resources equitably, reflecting proportional disparity, and based on student needs. This may include, for example, the specific needs of BIPOC (Black, Indigenous, People of Color) students, foster youth, unhoused youth, students who are emerging multilingual learners and students with disabilities."); and Technology Infrastructure ("Our learning spaces and integrated technology are accessible and adaptive to all students' needs. We learn from the adaptations we create for specific groups of students, for example, students with disabilities, or with language needs, and apply those learnings across the system.")

LBUSD is grateful for the thoughtful recommendations from the community to assist in the work of developing a budget—but more importantly, creating promising programs and services that assist students of LBUSD.

The following summarizes the actions and services that have been influenced by educational partner input. LBUSD finds it necessary to list recommendations and, if not in the LCAP, where it may be found in other plans or resources.

Goal Analysis for 2022-23

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

- 1.1: Assistance to Teachers: No substantive differences in planned actions and actual implementation. Due to achievement rates not meeting growth target goals (as indicated in the *Reflections: Identified Need* section), the District renewed emphasis on quality core instruction and professional development, began in the Spring 2022 and is continuing for the 2023-24 school year (Action 1.1).
- 1.2: Technology Infrastructure and Support Services: District utilized other one-time resources to purchase technology.
- 1.3: Plant/Maintenance Services (Base): Planned facility improvement projects are being pursued through the LCAP, including: asphalt and routine restricted maintenance spanning multiple years.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

- 1.1: Assistance to Teachers: There was an increase in the expenses due to the negotiated compensation package.
- 1.2: Technology Infrastructure and Support Services: Expenditures in this action were significantly lower than budgeted in that additional technology purchases were authorized in other one-time resources.
- 1.3: Plant/Maintenance Services (Base): Nothing has changed with general ground, custodial, or maintenance expenses. Even with increased Salaries and benefits from negotiations LBUSD realized reduced costs due to staffing openings, unfinished maintenance projects and movement of projects to outyears due to unavailability of items or contractors. Some planned facility improvements are being pursued in future years through the LCAP.

An explanation of how effective the specific actions were in making progress toward the goal.

The addition of curriculum coaches and specialists (Action 1.1) brought a high degree of instructional expertise directly to schools, whereby coaching and professional development were enhanced as a result. The results of the actions translated into better instructional practices in the classroom, including focused differentiation strategies and other best practices for instruction of English Learners. Also included within this goal was the BTSA program which provides highly individualized training to the newest in the profession, where each new teacher receives a personalized coaching plan with observations and feedback that enhance a new teacher's repertoire in classroom instruction. This action also ensured that teachers were working on receiving their full/clear credential which relates to the Metric M1.1.

M1.2 (Access to Curriculum) continues to be at 100% compliance.

As shown in M1.3, all but one of the 83 campuses was rated as "good" or "exemplary" repair. The plant maintenance schedules (Action 1.3) are integral to provide timely and ongoing maintenance of building and grounds, which directly impacts Metric M1.3.

An explanation of why the LEA has developed this goal.

To promote student growth, LBUSD must create a student-centered and anti-racist school experience that guarantees academic achievement, student agency, advancement, and a sense of belonging for all. The culture and climate of schools must be conducive to learning, embrace diversity as an asset, and encourage social-emotional development.

Specifically:

- While LBUSD has generally seen favorable responses in the Social-Emotional Learning Survey, it must be an area of focus as the pandemic took a toll on students and families, particularly unduplicated pupils.
- LBUSD has received positive marks in the School Culture and Climate Survey over the years, but the idea of safe, inviting, engaging, and supportive campuses must be prioritized as students returned from distance learning to in-person instruction.
- Parent participation in school decision-making processes and programs must continue to improve, especially among the families of unduplicated pupils.

This LCAP section reflects Goal 2 of LBUSD's Strategic Plan, which aims to:

Provide a safe, welcoming, respectful, and rigorous learning environment for every member of the school community.

- Cultivate an atmosphere where every student feels physically safe, emotionally supported, and academically challenged.
- Promote positive and respectful relationships with students, parents, employees, and other members of the school community.
- Provide opportunities for employees to develop meaningful relationships that positively impact their ability to serve students and grow professionally.

In looking at successes and challenges of implementing Actions of Goal 2, the continuing effects of the pandemic has been an ongoing issue for the community and for many of our students. LBUSD has taken a leading role in amplifying student voice, which gives adults authentic and actionable data. Action 2.2 emphasizes student advisories at schools. In 2022-23, the Superintendent visited all high schools and worked with a focus group of diverse students (selected by the students themselves) to explore survey data related to student agency, belonging and identity. Not only were students candid, but provided ideas for school improvement. Action 2.3 provides an opportunity for reflection about our Parent Outreach by using data from an independent communications audit. The result of the audit were suggestions about communication clarity and access, especially focusing on families who do not usually engage with educational issues. This is a continual challenge- finding the 'sweet spot' of how to keep the community informed and actively engaged when there are many competing family demands. Restorative Justice (2.4) has been embraced as a means to correct harm and improve connectedness, identity and belonging in the school community. The newly deployed pulse survey has given schools a live and tracked means to understand the student experience, which can lead to a safer, more inclusive school.

| 2.2 | Community and Ancillary Services (Supplemental/ Concentration) | As stated in the district's equity definition, LBUSD strives to uplift groups that have been historically marginalized, amplifying student voices and embracing the community as true partners in education. Community and ancillary services support this vision. The particular actions/services supported here are Student Advisory resources at the high school level. Specifically, LBUSD has allocated funds to develop student-led projects that address academic, behavioral, social-emotional, health, psychological, and other needs. These projects are expected to align with the State Priority Areas, LBUSD equity initiatives, and other local efforts, with an emphasis on low income pupils, English Learners, and foster youth to close opportunity gaps. Actions and services can be provided in school, group, or individual settings. A critical part of these services is ensuring that all families have access to engagement opportunities and two-way communication. Such access includes simultaneous translation utilizing Zoom, conference call lines, and other technological tools, including School Messenger and Carvas. This way, Spanish, Khmer, and other non-English speakers can participate fully in dialogue with school and district staff. An enhancement in LBUSD's Translation Unit has provided thousands of pages of translated documents as well as hundreds of hours of interpretation services for improved two-way communication and engagement. Goal Analysis for 2022-23

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

- 2.1- Community and Ancillary Services (Base): LBUSD's planned issuance of community permits were suspended during the COVID pandemic in order to promote health and safety of the community. Community permits were still low in 2022-23, however expenditures occurred as expected.
- 2.2- Community and Ancillary Services (Supplemental/ Concentration): No substantive differences in planned actions and actual implementation. In 2022-23, to enhance student experience on high school campuses, some schools engaged in projects that expanded seating for students during nutrition and lunch.
- 2.3- Parent Engagement / Outreach: An additional contract was added to the budget for an upgraded District website for better parent and community communication. LBUSD actively engaged several high school student groups, including student-led visioning sessions and the Superintendent's Student Advisory focus groups at each high school. The input gave valuable insight into the needs of students as represented by their sharing of their experiences.
- 2.4- Restorative Justice: No substantive differences in planned actions and actual implementation. Middle schools have increased training for restorative justice in 2022-23: At 6 middle schools, there are 221 staff fully trained, 162 coaching sessions, and over 3000 community circle participants. 4 more MSK8 schools are exploring training possibilities, as is the WRAP program.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

- 2.1- Community and Ancillary Services (Base): The usage of campuses for community use increased, as did the cost of employees to manage services during these open times. This led to an overall increase in expenditures.
- 2.2- Community and Ancillary Services (Supplemental/ Concentration): No substantive differences in planned actions and actual implementation.
- 2.3- Parent Engagement / Outreach: An additional contract was added to the budget for an upgraded District website for better parent and community communication.
- 2.4- Restorative Justice: No substantive differences in planned actions and actual implementation. There was an increase in the expenses due to the negotiated compensation package.

An explanation of how effective the specific actions were in making progress toward the goal.

Contributions to high school and middle school sports programs (Action 2.1) are an important part of developing a positive sense of belonging (Metric M2.3) for a school. In addition, community permits (also Action 2.1) help a school site become a better community partner by helping non-profit organizations conduct activities on site. This contributes to Metric M2.2- favorable response in the School Culture Climate Survey.

The Student Advisories at the high school level raise student voice and agency, a key factor in positive school climate (Metric M2.2) and student sense of belonging/school connectedness (Metric M2.3). Student advisories are in Action 2.2. This year, the Superintendent visited each high school and held a focus group of diverse students (selected by students members of the Superintendent's Student Advisory Committee). The results of the Pulse Surveys, which measured sense of belonging, student agency and identity, were the focus of discussions. In addition, students gave specific recommendations about changes that they feel would make a difference in belonging. These recommendations were reported to the Student Advisory and the principal. The Board of Education installed a Student Board Member. This has brought student voice to the governance of LBUSD.

Parent Outreach and Engagement/ Parent University, as well as interpretation services are included in Action 2.3. We saw a slight increase in parents feeling satisfied about their opportunities to participate at schools (Metric 2.5). Some foundational Parent University workshops- in English, Spanish, and Khmer- may have contributed to this increase.

Restorative Justice programs at the school sites have contributed to the overall safety and positive climate. Students participate in conversations of conflict resolution to add to a more positive climate. Metric M2.1 (Social Emotional Learning) and M2.2 (Culture and Climate) are positively affected by Restorative Justice (Action 2.4).

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

A change in action from last year includes Action 2.3: LBUSD Communications is using data analytics tools to track and measure parent engagement levels. These help identify areas where LBUSD can improve our engagement efforts and provide valuable insights into parent preferences and concerns. By using data analytics, LBUSD is tailoring our engagement strategies to better meet the needs of our diverse parent community, including historically underserved pupils/families, unduplicated pupils/families and families who are less likely to engage with staff in support of their child's education.

An explanation of why the LEA has developed this goal.

To access as many postsecondary options as possible, students must grow academically and demonstrate proficiency in key areas on a regular basis.

Specifically:

- While LBUSD has continued to make progress in English Language Arts and Mathematics, the achievement gap persists between subgroups, with unduplicated pupils lagging behind the district average
- While redesignation rates have continued to improve, overall progress for LBUSD's English Learners still has room for growth.
- Inequities have been exacerbated during the pandemic, so LBUSD must focus on learning recovery, particularly for unduplicated pupils.

This LCAP section reflects Goal 3 of LBUSD's Strategic Plan, which aims to: Promote academic growth for every student.

• Increase the number of students who meet or exceed standards in English Language Arts and Mathematics.

As stated in the Challenges section, the results of the state SBAC testing showed a drop in achievement in almost all areas. The data reaffirms the lasting effects of the pandemic on achievement and reminds us that the work of combating the learning loss is difficult. LBUSD did not see double digit drops as from the previous year, however we have not seen the gains anticipated. Our work with Quality Core Instruction and adoption of formative assessments deployed at the end of last year and augmented this year will hopefully make a difference. As LBUSD reflects on the summative results, we have recommitted ourselves to quality core instruction in all classrooms. Beginning in the summer of 2022, intensive training of all teachers commenced emphasizing a new "Understandings" continuum (see Action 3.1 for more details about the LBUSD "Understandings" framework, which supports culturally responsive educators in using an asset-based approach to create equity-centered classrooms. There are six understandings, or agreements, that comprise Quality Core Instruction and are integral for creating equitable and inclusive learning environments. Moving forward with ensuring quality core instruction in all classrooms is at the heart of LBUSD's improvement efforts for student achievement.

A new platform ("Ellevation"), designed to assist classroom teachers and school leaders in ensuring the success of English learners will be introduced to LBUSD teachers and leaders in the Fall. The Ellevation platform will assist classroom teachers, principals and district leaders in analyzing multiple sets of assessment data in order to make instructional decisions and set language development goals for English Learners. In addition, Ellevation supports integrated and designated instruction through materials and resources that support students' specific proficiency levels. The Ellevation platform tracks student progress toward English fluency and monitors students into and beyond the phase of redesignation. Teachers, principals and central office departments will have access to all English learner data as a means of collectively monitoring student acceleration, the interventions that are assigned to support students and their on-going progress toward academic success. In addition, a robust set of professional development modules will assist teachers in increasing their knowledge and capacity to support English learners in their language acquisition and content mastery through integrated and designated English Language Development. In winter 22-23, out of 596 eligible reclassification students 552 students were reclassified. Compared to during the same time last year, just under 500 students were reclassified. The new ELLevation system allows staff to know at which criteria is not allowing reclassification to happen. With accessible data available to parents, teachers, and central office staff, there is more engagement on data including every school site accessing this platform. ELLevation has been key in raising the overall awareness of EL student needs. Since classroom teachers have EL student data and reminders at their fingertips, ELD and other in-class supports have improved. Data shows that there was a 65% increase in students scoring a level 4 from last year.

"Newcomer" is a term for foreign-born students who have recently arrived in the United States. Newcomer students come from many different countries and diverse cultural backgrounds. These students come to school with various levels of educational experiences and speak a variety of languages. Many newcomers to LBUSD are English Learners. As newcomer students enter into a new education system, they may experience different academic, language, and social-emotional challenges from those of U.S. born students. It is vital to acknowledge the strengths and abilities newcomer students bring, as well as recognize and assist newcomer students as they navigate challenges. Newcomer students are protected under federal laws to access a free, accessible, and appropriate public education, regardless of home language or immigration status. Successful programs serving newcomer students are based in sound educational theory, are implemented effectively with adequate resources, and are proven effective in overcoming language barriers. In support of LBUSD Newcomers, a new program will be implemented at four school sites, called "Enlace". It will serve as a hub for newcomers in middle school. The program is coordinated by the Multilingual office and will include 4 EL TOSA positions. This position will include a combination of course teaching and coaching and staff. Enlace will be located at 4 sites strategically selected around the city: Washington, Franklin, Hamilton and Marshall. The hubs at the 4 schools will serve newcomers from anywhere in the City, regardless of where their home school may be in the District.

Numerous equity initiatives drive the actions and services in this section. Specifically, the goals of the community engagement initiative are to develop and build trusting relationships with all educational partners; create systems that provide opportunities for diverse perspectives to be shared; and enhance district methods for interacting with parents. The latter objective includes ensuring that all families have access to engagement opportunities and two-way communication, particularly when it comes to language. Moreover, from the standpoint of academic growth, the learning acceleration, support, and enrichment initiative focuses on the development of intervention models for literacy and math as well as other extended learning opportunities.

Goal Analysis for 2022-23

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

- 3.1- Instruction (Base): No substantive differences in planned actions and actual implementation. As noted in the Reflections- Identified Need section, achievement rates were disappointing. A renewed emphasis in quality core instruction was planned (Action 1.1) and professional development was implemented in 2022-23 and continuing into 2023-24. In addition, the LBUSD-created "Understandings", as an important cog in quality instruction, is being enhanced and uplifted in the aforementioned professional development.
- 3.2- Instruction-Related Services (Base): No substantive differences in planned actions and actual implementation. The re-energized "Understandings", which were enhanced to support culturally responsive instruction, held a priority in the system with a renewed emphasis on quality core instructions. This was a major focus of professional development in 2022-23 and many of the personnel included in Action 3.2 contributed to this work.
- 3.3- Instruction-Related Services (Supplemental/Concentration): No substantive differences in planned actions and actual implementation. LBUSD began work on auditing the curriculum to ensure that it is culturally-relevant and anti-racist. This work continued in 2022-23 and will continue into 2023-24, including professional development that focuses on implicit bias, equity and inclusive instructional practices.
- 3.4- General Administration and Other Services (Base): No substantive differences in planned actions and actual implementation. LBUSD enjoys a high rate of teacher and overall employee retention which, in part, can be attributed to Action 3.4.
- 3.5- Literacy Support: No substantive differences in planned actions and actual implementation. Literacy materials were purchased and implemented in support of the additional literacy teachers providing direct support to at-promise students.

- 3.6- Library Education Program: No substantive differences in planned actions and actual implementation. The anticipation of ELA/Literacy growth results, coupled with Action 3.5 may be partially attributed to teacher librarians and media assistants. ELA iReady results showed growth. For the 2023-24 SY, there will be some funding for basic library supplies.
- 3.7- English Learner Support: No substantive differences in planned actions and actual implementation. With the implementation of ELLevation, EL progress monitoring was substantially improved at the classroom and school levels. ELLevation provided data about students for ELPAC, SBAC, Grades, and iReady results, which helped teachers and schools keep up to date about the needs of EL students.
- 3.8- Mathematics Support: No substantive differences in planned actions and actual implementation. Intervention programs at the middle and high school levels have shown promise as evidenced by growth in iReady data.
- 3.9- Early Learning Initiative: No substantive differences in planned actions and actual implementation. The expansion of TK programs, CDC and "Early TK" programs is essential to prepare students for elementary grade skills, especially unduplicated students. The success of these programs led to planned expansion in the 2022-23 SY.
- 3.10- School-based Student Support: No substantive differences in planned actions and actual implementation. Action 3.10 is an affirmation of LBUSD's belief in "local control." Each school site receives an allocation of LCFF funds. A challenge is ensuring that interventions are implemented with fidelity, have reliable data and evaluated for its effectiveness for what it was intended to do. For the 2023-24 SY, the call for enrichment opportunities was heard and funding will be made available for elementary grade field experiences.
- 3.11- Learning Acceleration Programs: No substantive differences in planned actions and actual implementation. VEX Robotics at the middle school level has shown an increase in student participation.
- 3.12- Tutoring Support: Some of the tutoring support that was originally budgeted for this action have been funded using one-time COVID relief funds. The overall activity of tutoring has been fully implemented.
- 3.13- Black Student Achievement Initiative (Base): As the second year of implementation of this program grew, district staff and committee planned and implemented activities in alignment with this identified funding purposes.

- 3.10- School-based Student Support: There was an increase in the expenses due to the negotiated compensation package. Action 3.10 is an affirmation of LBUSD's belief in "local control." Each school site receives an allocation of LCFF funds and in some cases, personnel was approved by the school, which caused an increase due to compensation increases. Increases in salaries due to negotiated compensation packages were offset by the utilization of other funding sources (ELO-P) which provided before and after school care for students.
- 3.11- Learning Acceleration Programs: There was an increase in the expenses due to the negotiated compensation package.
- 3.12- Tutoring Support: Tutoring costs were increased in 2022-23 due to the usage of substitute teachers for tutoring activities at various sites throughout the District.
- 3.13- Black Student Achievement Initiative (Base): The District expects expenditures to grow as implementation of additional programs are implemented for 2023-2024.

An explanation of how effective the specific actions were in making progress toward the goal.

Goal 3 speaks to instruction and student supports. The investment is almost 75% of total funding through LCFF. The significance of making major investments in instruction and student supports should not be lost. This goal provides Teachers (3.1), Coaches/TOSAs (3.2), Classroom Aides (3.3), school support staff (3.4), Literacy and Math interventions (Actions 3.5 and 3.8), Librarians (3.6), English Learner support (3.7), TK programs (3.9), Electives (3.11), Tutoring (3.12). It also provides for interventions for two of our underperforming student groups- Black students (3.13) and English Learners (3.7). Through these investments, we are hopeful for a reversal in student achievement data, which has not been trending positively.

The negative effects of the pandemic continue to be a challenge, but we have continued to ensure a strong foundation for our students. Goal three (3) has many components where we continue to invest in basic needs to reach our unduplicated students. Action 3.1 (instruction) is meant to support M3.1 and M3.2. Many of our teachers continue to be challenged to expand their repertoire with more social-emotional supports for their students. By providing Teachers on Special Assignment (TOSAs), trainers, and coaches, we have been able to direct support to the teachers. Action 3.2 focused more on instruction related support which is directly connected to M3.1 and M3.2. By providing dedicated support for our unduplicated students through action 3.3, it has increased targeted interventions for our unduplicated students. Additionally, the classroom aides provided immediate support to students to help us reach M3.1 and M3.2 goals.

Literacy and Mathematics support: Actions 3.1, 3.2, and 3.3 have provided basic support needs for teachers and librarians, teachers on special assignment to provide culturally responsive anti-racism teaching and other direct support to teachers to welcome back a group of students having varied needs from the pandemic, Actions 3.5 and 3.6 continued to contribute to the support M3.1 goal. By providing additional intervention materials and literacy teachers to schools with higher concentrations of unduplicated pupils, the layered approach supported students who might have fallen behind 2 or more grade levels in literacy. The shift of Saturday schools and tutoring for the students requiring credit recovery or additional academic support allowed students to have alternative times to focus on academics. This can be found through Action 3.11 and 3.12 where the tutoring support was placed in 29 high-need schools. The focus of tutoring is in academic support specifically in English and Mathematics which aligns with M3.1 and M3.2. By providing additional support in Mathematics through Action 3.8, math interventions build on prior supports for students and prepare students for Algebra success. Due to factors surrounding the novel coronavirus (COVID-19) pandemic, testing participation in 2020–21 varied in that California districts were given the option to use a locally administered assessment in lieu of the SBAC. LBUSD opted to test with the summative state assessment in Math (grades 3-8 and 11) and English-Language Arts (grades 6-8 and 11), but chose to use a local assessment for English-Language Arts in grades 3-5. Care should be used when interpreting results. The data has not seen significant growth, however, the District is committed to providing these interventions and support to address the impact the students experienced due to the COVID19 pandemic.

For our English language learners, through Action 3.3 and 3.7, instruction, instructional aides, teachers, and the establishment of the LBUSD Multilingual Office are able to support students' need to meet M3.3 and M3.4. English Learners (EL) have varied needs and it is critical to have expectations and supports aligned with the student's parent and/or guardian. The Multilingual Office has enhanced the engagement with parents to be in alignment with the student's goal. The Multilingual Office is critical in leading the efforts to ensure that EL students receive the learning supports, including ELD- integrated and designated, in the classrooms. In addition, ELLevation has created a system to monitor all EL students, as we strive to ensure redesignation when a student is eligible. Newcomer support has been augmented with a pilot

program at four middle schools, which brings additional help to newcomer students (direct instruction) and staff (coaching). The EL support will transpire in M3.3 and M3.4 goals.

Aside from intervention support, by focusing on Early Learning Initiative (Action 3.9), it is critical for the District to focus on having a clear alignment on instruction for all students beginning at the earliest level. A solid foundation is important for immediate and long-term academic success to meet M3.1, 3.2, 3.3, and 3.4 goals.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Metric 3.5 was added to Draft 2, as it was left off the previous draft. This metric was established in the 2022-23 LCAP as Metric 3.5 and the metric description, nor any of the data has changed.

Metric 3.6 was added as it is now a requirement to enter a Science assessment metric. In LBUSD, the CAST (State Science Assessment) is given at grades 5, 8 and 12.

Metric 3.7 was added to indicate implementation of state standards, as measured by the state's Priority 2 Local Indicator tool.

Additional dedicated library materials will be an additional budgeted item as listed in Action 3.6.

As mentioned throughout the LCAP, English Learner supports will be increased as a result of a new program that will serve as a hub for newcomers in middle school. This program is entitled, "Enlace". The program is coordinated by the Multilingual office and will include 4 EL TOSA positions. This position will include a combination of course teaching and coaching and staff. Enlace will be located at 4 sites strategically selected around the city: Washington, Franklin, Hamilton and Marshall. The hubs at the 4 schools will serve newcomers from anywhere in the City, regardless of where their home school may be in the District. This is represented in Action 3.7.

Important to the community and student experience, a new budgeted item is planned for 2023-24 in Action 3.10. In addition to the LCFF allocation to all sites (Action 3.10 puts an allocation of LCFF funds to every school site), a new allocation will be made to enhance enrichment. Specific funding to all elementary schools (including K-8 schools) to support field trip experiences for elementary student grades will be allocated in SY2023-24.

Action 3.12 continues to fulfill a need for tutoring support and continues honor the concept of providing additional/supplemental tutoring beyond other planned tutoring programs that live within the LCAP. However, limiting this line item to a designated list of schools does not account for the changes in need since the list was developed over 3 years ago. There are several schools that are in need that do not appear on the original list and some schools on the original list are no longer in existence. Therefore, the list of schools was eliminated in favor of keeping to the spirit of why the list was created- to ensure the most needy students receive supplemental tutoring support.

In 2023-24, we are engaging in new Contracts for the 2023-24 SY to enhance the experience of Black students (Action 3.13): Historically Black Colleges & Universities (HBCU) Tours- for students to experience universities and showcase their talents; BridgeBuilders for mentoring Black male students; and the Math Literacy project for a content-rich and culturally-responsive math experience.

Although LBUSD is hopeful that we are nearing an endemic environment, the profound effects of school closures, isolation, lack of health resources and other factors related to the pandemic of two-plus years has accounted for student learning loss and increases in mental health related concerns for students. This impact has negatively affected many of the gains in readiness for the next level of education, including transitions of preK to Kindergarten, from elementary to middle school, from middle to high school and from high school to college or career. This includes academic and social-emotional development. Many of the actions specified in Goal 3 were targeting academic concerns. In Goal 4, one of the major actions focuses on counseling support and other services related to social-emotional learning (SEL) and mental health.

- 4.1- Counseling Support: No substantive differences in planned actions and actual implementation. LBUSD added staff to help address social-emotional and mental health concerns reflective of the effects of the pandemic on the community.
- 4.2- College and Career Readiness: No substantive differences in planned actions and actual implementation. LBUSD re-engaged in the Long Beach College Promise College Tours in 2022-23. Every 4th and 5th grade student took a college readiness trip to Long Beach City College (LBCC- 4th grade) and Cal. State, Long Beach (CSULB- 5th grade). This program was canceled during the pandemic years, however we plan to continue the trips in 2023-24.
- 4.3- Advanced Placement Support: No substantive differences in planned actions and actual implementation. LBUSD increased the percentage of 11th and 12th grade students who enrolled and passed at least one AP course, which shows promise for students afforded by Action 4.3.

The results presented in Metric 4.2 for ELA in 2020-21 was changed from 30% to 35.5%. There was an error in calculation last year as a result of students who were conditionally exempt at the time of the calculation. Once this was resolved (after the LCAP was reported last year), a new calculation was made to finalize the data.

College and Career data was not reported by California for 2022- M4.4

An explanation of why the LEA has developed this goal.

Regular attendance and engaged learning are vital to raising academic success, reducing achievement gaps, and improving college and career readiness.

Specifically:

- Chronic absenteeism has increased substantially due to the pandemic's effect on the health of the community.
- Suspension and expulsion rates show inequities. Students of color and male students are disproportionately suspended and expelled. In addition, the effects of isolation during the school closures has exacerbated the problem of connectedness with school, social norms and how to cope with disagreements. LBUSD engaged in a "Smart Start" to try to work on the social-emotional issues as students re-integrated back to school "Smart Start" provided mixed results.
- The percentage of high school students who are on track to graduate declined, with ninth graders, tenth graders, and unduplicated pupils among the most adversely impacted. Historically, this metric correlates with the graduation and dropout rates.

Goal Analysis for 2022-23

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

- 5.1- Pupil Services (Base): No substantive differences in planned actions and actual implementation. There was an increase in the expenses due to the negotiated compensation package. The mental health support providers at schools have increased dramatically -an increase in 70 FTEs since 2020, including Counselor, Psychologist, and School Social Workers. These professionals provide support to students in our efforts to attend to the "whole child."
- 5.2- Pupil Services (Supplemental/Concentration): LBUSD faced a challenge in hiring for several vacancies, including nurses and psychologists, LBUSD utilized nursing contracts to support student needs.
- 5.3- Wellness Centers: LBUSD has received very positive feedback regarding the wellness centers. The data from the Centers unequivocally show the need for this type of intensive student support. We expanded the Wellness Centers into middle schools in 2022-23.
- 5.4- Male and Female Leadership Academies: The Male and Female Academy programs are functioning well, however some of the programs are slow to implement some of the planned programs, including field experiences, due to shortage of buses.
- 5.5- Foster Youth Services: No substantive differences in planned actions and actual implementation. In providing support to foster youth by improving services through social workers, an improved tracking system and more developed relationship with Long Beach and County agencies was a positive result of Action 5.5.
- 5.6- Linked Learning Initiative: No substantive differences in planned actions and actual implementation. Able to utilize already awarded funding for Project Lead the Way expenditures that was offset by increased expenses for personnel due to an increase in the negotiated compensation package. Extra support for Linked Learning at the high school level has assisted many Pathways to gain silver and gold certifications, which indicates that the program is recognized for their commitment to excellence and equity in education. 11 LBUSD High School Pathways earned gold or silver certifications.

5.7- Elementary Music Program: No substantive differences in planned actions and actual implementation. LBUSD has a challenge with a wait list for students to receive musical instruments and instruction. However, we are anticipating the elimination of this wait list in 2023-24 due to the utilization of other resources (which will not eliminate this budgeted item).

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

- 5.1- Pupil Services (Base): No substantive differences in planned actions and actual implementation. There was an increase in the expenses due to the negotiated compensation package
- 5.2- Pupil Services (Supplemental/Concentration): There was an increase in the expenses due to the negotiated compensation package and increased nursing contracts.
- 5.3- High School Wellness Centers: Increased costs related to the opening of Middle School Wellness Center with opening activities purchasing of supplies and furnitures as well as staffing each middle school wellness center with a part time social worker.
- 5.4- Male and Female Leadership Academies: Due to the pandemic's effect on health and safety conditions for field experiences, there will be some expenditures that were planned, but not fulfilled. There will be some carry over in the budget for Action 5.4.
- 5.5- Foster Youth Services: There were no significant differences in budget and estimated expenditures.
- 5.6- Linked Learning Initiative: There were no significant differences in budget and estimated expenditure as there was an offset between compensation and a program planned that used a different resource.
- 5.7- Elementary Music Program: There were no significant differences in budget and estimated expenditures.

An explanation of how effective the specific actions were in making progress toward the goal.

Additional site allocation of nurses, health assistants, psychologists, school safety therapists (Action 5.2) supported students, especially in the wake of the COVID pandemic, which affected a tremendous amount of students- both academically and emotionally. These important resources for students and their well-being have proven invaluable in serving unduplicated students and to bring a caring environment to the school, improving sense of belonging, identity and agency.

High School Wellness Centers (Action 5.3) were introduced at all high schools to provide an extra layer of support for students. The expansion of the wellness centers to the middle schools has also proven to be successful. These 'safe spaces' helped students find support for themselves as they navigated a difficult transition back to school. It also provided referrals to other supportive agencies as well as a "brain break" for overwhelmed students. Data surrounding the Wellness Centers show the need to invest in this support and other supports for improved mental health of students. The use of the Centers continues to be high with current year data as follows (2022-23: September through February):

High School:

Over 2500 counseling check-ins;

Over 2000 individual counseling sessions

Over 800 group counseling sessions and workshops

Middle School:

Over 4000 counseling check-ins;

Over 2500 individual counseling sessions

Over 1500 group counseling sessions and workshops

These two actions, in particular, have made a significant impact on Attendance Rate (Metric M5.1), Chronic Absenteeism Rate (M5.3), Suspension Rate (M5.4), Expulsion Rate (M5.5) and Dropout Rate (M5.7). It is of note that these metrics showed a negative trend; however, we feel that the additional actions, as described above, prevented a greater number of students who may have had more difficulty in the adjustment process if LBUSD did not provide this support.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

As in the past few years, the state no longer reports middle school dropout data (M5.6). However, LBUSD calculated this internally, which is added to the metric report.

The additional language added in Action 5.1 (final paragraph) describes the increased support for student mental health at schools in an attempt to provide the community with relevant information about mental health supports that come from multiple providers/positions. Support has increased dramatically -an increase in 70 FTEs since 2020- including Counselor, Psychologist, and School Social Workers. These professionals provide support to students in our efforts to attend to the "whole child." LBUSD's ratio of mental health provider staffing has seen dramatic decreases in provider to student ratio, which is a testament to meeting the needs of students in this area. For the 2022-23 school year, the mental health provider to student ratio is 280:1, including Counselor, Psychologist, and School Social Workers. Please see page 9 of this LCAP for more information.

Required Descriptions

For each action being provided to an entire school, or across the entire school district or county office of education (COE), an explanation of (1) how the needs of foster youth, English learners, and low-income students were considered first, and (2) how these actions are effective in meeting the goals for these students.

The following actions are (1) being provided districtwide and (2) principally directed to and effective in meeting the needs of low-income students, English Learners, and foster youth. The actions are categorized by LCAP goals.

Goal 1

Action 1.1 Assistance to Teachers

- •There has been a call for professional development in social-emotional learning, English Language Development, and culturally responsive pedagogy that accelerates learning for low-income students, English Learners, and foster youth.
- •LBUSD orients its Beginning Teacher Support and Assessment (BTSA) and National Board Certification programs toward coaching both new and experienced educators on differentiating instruction for unduplicated pupils. In addition, Teachers on Special Assignment deliver training on ensuring positive relationships with low-income students, communicating with hard-to-reach families (particularly foster families), and supporting English Learners with language development.
- •Research from Educational Leadership (among many other publications) indicate that consistent, integrated teacher supports on social-emotional learning, English Language Development, and culturally responsive pedagogy have positive benefits on student achievement. These benefits should translate to improved Smarter Balanced results in English Language Arts and Mathematics for low-income students, English Learners, and foster youth.

Action 1.2 Technology Infrastructure and Support Services

•The deployment of thousands of devices and technology tools (including hotspots) during the pandemic reflects the general effectiveness of these actions and services.LBUSD's distribution approach is principally directed to unduplicated pupils by locating the hotspots and other materials where the needlest families, as determined by survey results, can readily access them. Since low-income students, English Learners, and foster youth tend to be among the hardest to reach, additional outreach helps ensure that they can benefit from more reliable internet connectivity. The "tech gap" was exasperated by the pandemic of the past two years. The deployment of updated technology is imperative, especially for unduplicated pupils. The intended outcome will contribute toward meeting M3.1/M3.2 (Meeting

Standards). More specifically, it is expected that the percentage of low income students, foster youth and English learners who meet or exceed standards in English Language Arts (M3.1) and Mathematics (M3.2) will increase.

Goal 2

Action 2.2 Community and Ancillary Services (Supplemental/ Concentration)

•Additional adult-to-student connections are critical for unduplicated pupils. Educational partner feedback has consistently called for proactive measures to engage low-income students, English Learners, and foster youth, whose sense of belonging in school has historically been lower than their peers and affected their academic performance. In the School Culture and Climate Survey, for example, unduplicated pupils have tended to provide relatively fewer positive responses when asked whether they "feel close to people at school" or "feel like [they] are part of the school." The intended outcome of Action 2.2 is to improve the Sense of Belonging of students (M2.3). This initiative focuses on uplifting student voice by discussing student experience between student groups and school site leaders. More specifically, it is expected that the percentage of favorable responses from low income students, foster youth and English learners in the CORE survey- Sense of Belonging (School Connectedness) (M2.4) will increase.

Action 2.3 Parent Engagement / Outreach

- •Low-income students, English Learners, and foster youth have historically experienced significant trauma and had limited access to social, emotional, and behavioral health-related services in their communities. Their families have also had the greatest needs in terms of engagement, particularly when it comes to language access. A critical part of these services is ensuring that all families have access to engagement opportunities and two-way communication. Such access includes simultaneous translation available at parent engagement opportunities/events. This way, Spanish, Khmer, and other non-English speakers can participate fully in dialogue with staff.
- •Additional parent engagement and outreach efforts principally benefit the needlest families, who require extra support to overcome challenging circumstances, particularly when it comes to language access. LBUSD anticipates that, with these services, low-income students, English Learners, foster youth, and their families will express a greater sense of belonging in the School Culture and Climate Survey, as measured in M2.3 and 2.4.

Action 2.4 Restorative Justice

- •Restorative justice workshops encourage conflict resolution, cultural awareness, positive behavior supports, and other alternatives to suspensions and expulsions. They help address the unique needs of unduplicated pupils, who have higher rates of discipline and suspension.
- •Restorative justice workshops facilitate services that uplift unduplicated pupils and other students who have been historically marginalized. They provide a forum that amplifies student voices and embraces the community as true partners in education. They also have a distinct emphasis on social-emotional learning, which principally benefits low-income students, English Learners, and foster youth, who experience trauma and related challenges at higher rates than their peers.
- •Like most school districts, unfortunately, LBUSD data suggests that males of color, including low income, foster and EL students are referred, suspended and expelled at a higher rate than their peers. Preventative measures, such as Restorative Justice, aims to promote cross-cultural and linguistic relationships and create more inclusive school communities, which, in turn, will reduce suspension and expulsion for males of color, including low-income, foster and EL students.

Goal 3

Action 3.3 Instruction-Related Services (Supplemental/Concentration)

•In general, LBUSD's achievement gap has negatively impacted low-income students, English Learners, and foster youth -- something that has been exacerbated by the pandemic. Extended, targeted supports and interventions are necessary. It is expected that the percentage of low income students, foster youth and English learners who meet or exceed standards in English Language Arts (M3.1) and Mathematics (M3.2) will increase.

- •Classroom Aides and other instruction-related staff members are tasked to work with teachers in classrooms where the achievement gap is the hardest to close. They help provide more individualized instruction and targeted interventions to low-income students, English Learners, foster youth, and others who are struggling and require additional attention. They also free up the teachers' ability to devote more instructional time directed at the needs of unduplicated pupils. In targeting foster, EL and low income students who are struggling to meet standards, instructional aides provide a small group and/or 1:1 support. For EL students, primary language support from aides assists the student to understand the academic language of the classroom, which is often a barrier to learning. Also for English Learners, a classroom aide may help support the designated ELD program.
- •The placement of Classroom Aides and other instruction-related staff members in classrooms with substantial academic needs and high concentrations of unduplicated pupils ensures that the supports are individualized and targeted. The enhanced instruction helps accelerate learning for low-income students, English Learners, foster youth, and others who are struggling.

Literacy Support (3.5) / Library Education Program (3.6) / Mathematics Support (3.8) / School-based Student Support (3.10) / Learning Acceleration Programs (3.11) / Tutoring Support (3.12)

- •Unduplicated pupils have generally fallen behind their peers in English Language Arts and Mathematics -- an issue that tends to persist throughout the TK-12 system. Low-income students, English Learners, and foster youth require individualized support from highly trained teachers. Furthermore, they need extended learning opportunities beyond the school day to accelerate academic progress. Such interventions have been among the top priorities for educational partners.
- •Literacy support, library education, and mathematics support address the needs of unduplicated pupils in several ways. First, highly trained teachers who are skilled in research-based instructional practices and programs can help reteach ELA and math content in different ways, accounting for the experiences of low-income students, English Learners, and foster youth. They can deliver coaching and professional development sessions that assist other teachers in acquiring such skills. Moreover, tutoring and other such interventions outside the regular day -- i.e., before school, after school, weekends- are designed to prioritize the highest-need students. They also often utilize materials that are particularly effective in engaging and supporting unduplicated pupils. Beyond these districtwide, subject-specific interventions, school-based student support, learning acceleration programs, and tutoring support for high-need sites create an additional layer of academic services that deepen engagement with unduplicated pupils at specific campuses.
- •Many of the services of Goal 3 are concentrated in high-need schools, where those who have historically struggled get the highest priority for support. School-based student support, learning acceleration programs, and tutoring support further enhance the academic services that unduplicated pupils receive at specific campuses. In combining these efforts, LBUSD is concentrating on supports and interventions, especially in Math and English-Language Arts. These actions will principally focus on M3.1/M3.2 (Achieving Standards). More specifically, it is expected that the percentage of low income students, foster youth and English learners who meet or exceed standards in English Language Arts (M3.1) and Mathematics (M3.2) will increase.

Action 3.9 Early Learning Initiative

- •Early Transitional Kindergarten, Transitional Kindergarten and Educare substantially expands early learning opportunities for low-income students and other unduplicated pupils, as they provide more options for families throughout the district. These programs are aligned with elementary schools, ensuring smoother transitions to kindergarten and enhancing school readiness. The focus on enhancing these early learning programs stems from the abundance of research that upholds the notion that providing a social-emotional and academic foundation for preschool children is an integral part of success in elementary school and beyond. For students who may come at a deficit, early learning programs, such as TK, CDC and Educare provide readiness interventions. LBUSD's history with subsidized CDC and Head Start programs has been successful by providing quality, age-appropriate instruction and interventions that can be a catalyst for catching and mitigating skill gaps.
- •The expansion of early learning services generally leads to greater participation among young children in structured, developmentally appropriate programs. English Language Arts and Mathematics achievement at the early grades are expected to improve, particularly for low-income students, English Learners, and foster youth.

Goal 4

Action 4.1 Counseling Support

- •Counseling services are part of LBUSD's holistic approach to wellness, and their work has a specific emphasis on connecting with families who are experiencing trauma like never before. This process includes not just reaching out to unduplicated pupils (particularly those who have been disengaged), but also identifying the social-emotional resources that they and their parents need. Counselors coordinate with the School-Based Mental Health Collaborative and other partners (both internal and external) to support families.
- •The emphasis on reaching students and parents who have struggled to remain engaged principally benefits unduplicated pupils, who are experiencing higher rates of chronic absenteeism, trauma exposure, and other challenges beyond academics. Moreover, the emphasis on connecting low-income, English Learner, and foster youth families with social-emotional and mental health resources directly responds to a priority that they have articulated.
- •Counselors provide SEL support in a targeted manner for foster, EL and Low income students with best practices, as mentioned above. The outcome will be measured on the Sense of Belonging/Connectedness data from the CORE District Survey with a 2% per year increase in positive responses for each targeted group, namely foster. EL and Low income students.

Action 4.2 College and Career Readiness

- •Unduplicated pupils have historically seen lower rates of high school, college, and career readiness. In part, this opportunity gap stems from financial barriers confronted by low-income students, English Learners, and foster youth.
- •The college advisor program, coordinated in partnership with the University of Southern California, places a specific emphasis on supporting first-generation, low-income, and underrepresented students. Its 'near-peer' model helps bridge the gap between the students and the advisors, who typically have the same background. The Ethnic Studies Program, in partnership with the California State University, Long Beach, aligns with LBUSD's efforts toward culturally responsive teaching and culturally relevant curricula.
- •Unduplicated pupils have less access to preparatory programs that open up opportunities to high school pathway programs, college, and careers. The needs of low-income students, English Learners, and foster youth are particularly acute in the midst of trauma exposure, necessitating direct services that account for their unique lived experiences. The efforts in this action focus on increasing high school (M4.1) and college readiness (M4.2/M4.3- Readiness for College- ELA/Math; M4.5 "A-G" Completion; M4.6 & 4.7- CTE Pathway Completion; and M4.8 Enrolling in College) foster, EL and Low income students..

Action 4.3 Advanced Placement Support

- •The cost of Advanced Placement participation, especially the fees associated with exams, serves as a substantial financial barrier for low-income students. It limits their access to AP courses and prevents them from potentially earning college credits.
- •LBUSD allocates funds to increase the number of AP courses that are available to students, thereby expanding opportunities for unduplicated pupils to challenge themselves academically. By subsidizing AP exam fees, the district significantly lowers the financial barrier and allows students to get the most out of their courses. In addition, support for students who engage in AP courses is important to ensure successful completion of the coursework.
- •Expanded course offerings and exam fee subsidies are expected to boost AP enrollment and test taking. In turn, college-going rates should increase, particularly for low-income students, English Learners, and foster youth. M4.9 & 4.10- Percentage of 11th and 12th graders who enroll and pass AP exams- are directly impacted by this Action.

Goal 5

Action 5.2 Pupil Services (Supplemental/Concentration)

•Due to their limited access to health-related services, low-income students, English Learners, and foster youth are at greater risk of trauma, especially after the pandemic. More than ever, they require coordinated mental health assistance, family outreach, and referrals to district and community resources.

- •Like counseling support, psychological and nursing services are part of LBUSD's holistic approach to wellness, and their work has a specific emphasis on connecting with families who are experiencing trauma like never before. This process includes not just reaching out to unduplicated pupils (particularly those who have been disengaged), but also identifying the social-emotional resources that they and their parents need. Psychologists and nurses coordinate with the School-Based Mental Health Collaborative and other partners (both internal and external) to support families. By adding nurses and nurse assistants, low-income, foster and English learner students should experience increased attendance (M5.1) and a reduction in chronic absenteeism (M5.3). In addition, the support from psychologists should enhance efforts in school connectedness (M2.3) and relationships (M2.1) for foster, EL and Low income students.
- •The emphasis on reaching students and parents who have struggled to remain engaged principally benefits unduplicated pupils, who are experiencing higher rates of chronic absenteeism, trauma exposure, and other challenges beyond academics. Moreover, the emphasis on connecting low-income, English Learner, and foster youth families with social-emotional and mental health resources directly responds to a priority that they have articulated.
- •Last year, LBUSD hired 20 agency RNs (school nurses) to assist with various duties including working with low income families to assist in health related issues and provide referrals to community agencies.

Action 5.3 Middle and High School Wellness Centers

- •Due to their limited access to health-related services, low-income students, English Learners, and foster youth are at greater risk of trauma, especially after the pandemic. In addition to structured services from psychologists, nurses, mental health professionals, and counselors, students need a place on campus where they can receive immediate support, as needed.
- •The Middle and High School Wellness Centers provide a safe space on campus where students can drop in to receive social-emotional support during the school day. These centers can be of assistance and support with conflict resolution, short-term individual/group counseling, stress management, and more.
- Wellness Centers are expected to address social-emotional needs that would otherwise prevent students from being actively engaged in their learning. Attendance rates should improve, and suspensions, expulsions, and dropouts should decrease. In fact, data supports the need with the hundreds of visits for "on call" support and the overwhelming student advocacy for continuance of the program. The metrics that should be positively affected by the wellness centers will be: low-income, foster and English learner students should experience increased attendance (M5.1), a reduction in chronic absenteeism (M5.3), and- as measured in the CORE survey- an increase in school connectedness (M2.3) and relationships (M2.1).

Action 5.4 Male and Female Leadership Academies

•Male and Female Leadership Academies empower unduplicated pupils through academic, cultural, and social-emotional supportMale and Female Leadership Academies provide learning opportunities that uplift unduplicated pupils and other students who have been historically marginalized. They provide a forum that amplifies student voices and embraces the community as true partners in education. They also have a distinct emphasis on social-emotional learning, which principally benefits low-income students, English Learners, and foster youth, who experience trauma and related challenges at higher rates than their peers. The metrics that should produce improvement through the mentorship and leadership of these academies for foster, EL and Low income students.are: reducing the Suspension Rate (M5.4) and increasing Readiness metrics (M4.1-4.4).

Action 5.6 Linked Learning Initiative

- •At the high school level, Linked Learning provides rigorous coursework, technical training, work-based learning, and related student services. Pathway programs ensure that student voices are incorporated in decisions related to their classroom experience, school experience, and the district curriculum. Social-emotional learning is a key priority, especially in building cross-cultural relationships and cultivating adult and student practices that create more inclusive school communities. SEL objectives are integrated into core and elective content and instruction, which reflect culturally responsive teaching.
- •Linked Learning pathway programs create educational experiences that uplift unduplicated pupils and other students who have been historically marginalized. They provide a forum that amplifies student voices and social-emotional learning, which principally benefits low-income students, English Learners, and foster youth, who experience both academic and non-academic challenges at higher rates than their peers. These programs will increase the graduation rate for foster, EL and low income students by enhancing the connection between the course objectives and life application, thus increasing engagement, growth mindset and self-efficacy.

Action 5.7 Elementary Music Program

- •Elementary music teachers deliver 10 to 16 sequential standards-based general-vocal music lessons for all kindergarten through fifth grade classrooms, 16 weeks of recorder lessons for all third grade classrooms, weekly violin instruction for fourth and fifth grade, and weekly wind instrument instruction (flute, clarinet, and trumpet) for fifth grade. The objective is to support low-income and other unduplicated pupils who would otherwise have no access to a rigorous music program. A planned change for SY23-24 maintains there will be no waitlists for elementary instrumental music- all students who wish to participate, will be able to. This principally benefits unduplicated students, who traditionally may not have access to musical instruments.
- •Unduplicated pupils have fewer opportunities to participate in non-academic programs that support their overall well-being, so elementary music creates experiences that principally benefit them. It promotes the healthy growth and development of children through the study, practice, and performance of music, and develops motor skills, brain functions, study habits, self-esteem, and teamwork all at a time when they are enduring trauma at higher rates than their peers.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

At a base level, the LCAP outlines how they are addressed for the entire school system, describing foundational systems for instruction, district curriculum, assessments, professional development, materials, and technology. Even with this base intact, low-income students, English Learners, and foster youth face substantial hurdles. They remain at great risk of suffering learning loss and academically falling further behind their peers; experiencing social-emotional trauma; and becoming disengaged.

LBUSD has strategically aligned its resources to increase or improve services for unduplicated pupils.

Goal 1 Action 1.1 Assistance to Teachers

The Beginning Teacher Support and Assessment (BTSA) and National Board Certification programs, alongside the Teachers on Special Assignment, augment the foundational professional development received by LBUSD educators in a way that improves academic support for unduplicated pupils. With their core skills intact, new and veteran teachers gain additional capacity building opportunities on social-emotional learning, English Language Development, and culturally responsive pedagogy that accelerates learning for low-income students, English Learners, and foster youth, and these opportunities are tailored to the experience level of the educator. Curriculum coaches and Program Specialists target their coaching on high needs schools first, thus ensuring the teachers in schools with high concentration of unduplicated pupils are appropriately prepared to provide quality core instructional practices.

Action 1.2 Technology Infrastructure and Support Services

Since low-income students, English Learners, and foster youth tend to be among the hardest to reach, additional outreach helps ensure that they can benefit from more reliable internet connectivity. This action continues to be important to ensure low income students have the technology needed for access into classroom learning and communication. Newer, better technology is important in providing low-income students with powerful tools to assist in learning standards, as well as contributes to closing the digital divide. Keeping up with the always evolving connectivity and educational technology provides unduplicated pupils the extra support needed in their daily classroom experiences.

Goal 2

Action 2.2 Community and Ancillary Services (Supplemental/ Concentration)

The coordination of community and ancillary services help form a supportive approach that principally benefits low-income students, English Learners, and foster youth, whose struggles can often lead to disengagement and a limited sense of belonging in school. The emphasis on increasing adult-to-student connections benefits unduplicated pupils who are experiencing a sense of belonging at lower rates than their peers. Student committees have focused on three areas: sense of belonging, student voice and student agency. The recognition of need for student-led advocacy groups gives students a voice in their learning, and unduplicated students benefit from their peer advocacy by ensuring typically under-represented voices are heard. In fact, the Superintendent's Student Advisory Committee hosted the Superintendent

at each high school to analyze Pulse Survey data (belonging, agency, and identity) and discuss student experience as it relates to these attitudes. In addition, these discussions led to solutions about how to improve student experience, as well as uplifting student voice.

Action 2.3 Parent Engagement / Outreach

Additional parent outreach and services need to go beyond traditional mass communications, which tend to be insufficient for families of low-income students, English Learners, and foster youth. Unduplicated pupils have historically experienced significant trauma and had limited access to social, emotional, and behavioral health-related services in their communities. Their families have also had the greatest needs in terms of engagement, particularly when it comes to language access. A critical part of these services is ensuring that all families have access to engagement opportunities and two-way communication. Simultaneous translation is a key to this action. This way, Spanish, Khmer, and other non-English speakers can participate fully in dialogue with school and district staff.

Parent University provides a wealth of information and workshops that enable participants to not only learn about many different topics, but also share resources and referrals to other community agencies that may benefit families, such as English Learners, Foster Youth and Homeless youth. This action also increases access to understanding how to navigate the school system- something that underrepresented families, including Newcomers/English Learners, need in order to advocate for their students.

LBUSD Communications is using data analytics tools to track and measure parent engagement levels. These help identify areas where LBUSD can improve our engagement efforts and provide valuable insights into parent preferences and concerns. By using data analytics, LBUSD is tailoring our engagement strategies to better meet the needs of our diverse parent community, including historically underserved pupils/families, unduplicated pupils/families and families who may be less likely to engage with staff in support of their child's education.

Action 2.4 Restorative Justice

The limited sense of belonging and school connectedness that unduplicated pupils experience stems at least partly from the dissonance between their learning opportunities and their lived experiences. Restorative justice workshops encourage conflict resolution, cultural awareness, positive behavior supports, and other approaches that are rooted in student voices. They view diversity as an asset, embrace the community as true partners in education, and have a distinct emphasis on social-emotional learning, which principally benefits low-income students, English Learners, and foster youth, who experience trauma and related challenges at higher rates than their peers.

Goal 3

Action 3.3 Instruction-Related Services (Supplemental/Concentration)

The placement of Classroom Aides and other instruction-related staff members in high-need classrooms increases the opportunities that unduplicated pupils have to receive academic interventions, particularly in English Language Arts and Mathematics. The quality of educational services for low-income students, English Learners, and foster youth improves, as well. With support staff providing assistance, teachers have the ability to assess the needs of struggling students with greater precision, so instruction can be differentiated and interventions can be targeted. Social-emotional learning can also be tailored to those who require additional attention.

Culturally-responsive anti-racism materials enhance classroom understanding of the experience of traditionally underserved populations and culturally responsive teaching has shown to improve the academic achievement of ethnically and racially diverse students. LBUSD's intention is to greatly increase anti-racist materials in order to uplift the experiences of students of color and to deepen empathy, compassion, and relationship skills, as well as embracing a strengths-based approach to learning and development that serves as a counter to deficit thinking and exclusionary practices.

Action 3.7 English Learner Support:

Action 3.7 focuses additional services for identified English Learners. LBUSD is building a responsive language accessibility unit to enhance translation, interpretation, and educational partner support. Additional translators/interpreters are funded through this LCAP. Additionally, the LBUSD Multilingual Office was established to ensure a focus on the needs of English Learners with personnel dedicated and specializing in EL pedagogy, instruction, professional development and curriculum for ELs. Staff in the Multilingual Office provide technical assistance to sites so they can deliver a quality program to ELs.

Action 3.7 provides for a cohort of school sites with the highest EL populations to prioritize additional professional learning. EL coaches and curricula specialists provide on-site training for school sites to address school-specific needs related to ELs, including primary/heritage language instruction strategies and curricula. These additional professional learning activities, including the assignment of coaches, are provided as differentiated resources for high need schools.

As described in Action 3.7, Ellevation is an improved service that assists classroom teachers, principals and district leaders in analyzing multiple sets of assessment data in order to make instructional decisions and set language development goals for English Learners.

In support of LBUSD Newcomers, Action 3.7 includes a new program to be implemented at four school sites, called "Enlace". It will serve as a hub for newcomers in middle school. The program is coordinated by the Multilingual office and will include 4 EL TOSA positions. This position will include a combination of course teaching and coaching and staff. Enlace will be located at 4 sites strategically selected around the city: Washington, Franklin, Hamilton and Marshall. The hubs at the 4 schools will serve newcomers from anywhere in the City, regardless of where their home school may be in the District. Many newcomers to LBUSD are English Learners. As newcomer students enter into a new education system, they may experience different academic, language, and social-emotional challenges from those of U.S. born students. This program is based on research that shows that a program that specifically is built for EL Newcomers can speed the progress toward English proficiency.

Literacy Support (3.5) / Library Education Program (3.6) / Mathematics Support (3.8) / School-based Student Support (3.10) / Learning Acceleration Programs (3.11)/ Tutoring Support (3.12)

By focusing on high-need schools with substantial concentrations of unduplicated pupils, literacy support, library education, and math support help increase access to structured interventions for low-income students, English Learners, and foster youth. They expand opportunities to address learning loss. In particular, highly trained teachers who are skilled in research-based instructional practices and programs can help reteach ELA and math content in different ways, accounting for the experiences of unduplicated pupils. On top of these services, school-based student supports, learning acceleration programs, targeted tutorials, English Learners, and foster youth. Through their establishment outside the regular day -- i.e., before school, after school, on weekends- they are, by definition, designed to extend learning opportunities. Tutoring support for high-need sites creates an additional layer of academic services that deepen engagement with unduplicated pupils at specific campuses. These types of structures are conducive to unduplicated pupils, who are often the principal beneficiaries of interventions that are tailored to their specific gaps in knowledge.

Action 3.9 Early Learning Initiative

The Early Learning Initiative establishes the Early Transitional Kindergarten, Transitional Kindergarten and Educare programs, which expand early learning opportunities, particularly in communities with high concentrations of unduplicated pupils. This expansion increases the access that low-income students, English Learners, and foster youth have to structured, developmentally appropriate educational services. It also enhances their school readiness and improves their transition to kindergarten in ways that help close achievement gaps with their peers.

Goal 4

Action 4.1 Counseling Support

Additional counseling services help form a supportive approach that principally benefits low-income students, English learners, and foster youth, who are experiencing higher rates of chronic absenteeism, trauma exposure, and other challenges beyond academics. To support the increased need for counseling support, additional social workers and counselors were hired to support the child welfare and attendance team as well as the foster youth unit and homeless education programs. These additional staff, trained in counseling and case management engage in strategic and intensive outreach efforts to support students with counseling, case management and

resources. Personal check ins, an often used strategy, help forge a connection with unduplicated pupils. Similarly, the delivery of personalized targeted social-emotional and mental health support -- either directly by counselors, social workers or school psychologist or through the School-Based Mental Health Collaborative and other partnerships -- addresses the challenges of unduplicated pupils, whose access or to such resources is generally limited and/or underutilized due to the stigma that surrounds mental health. Developing genuine relationships with students and families, builds the rapport necessary to allow them to fully access the mental health resources provided.

Action 4.2 College and Career Readiness

Targeted services come in the form of college advisors provided by a partnership with the University of Southern California and the Southern California College Advising Corps. These staff members focus on low-income students, who receive assistance with college applications, financial aid forms, campus visits, and other postsecondary issues. They address higher education access issues that go beyond what most of their classmates receive, including family support for first-generation college students. Moreover, the Ethnic Studies Program not only provides culturally relevant curricula for unduplicated pupils, but it also gives them a chance to earn college-level courses that they might otherwise be unable to access.

Action 4.3 Advanced Placement Support

By investing in greater numbers of Advanced Placement courses and reducing the cost of exam fees, LBUSD substantially lowers financial barriers for low-income students and increases their opportunities to earn college credits. These services ensure greater access to higher education.

Goal 5

Action 5.2 Pupil Services (Supplemental/Concentration)

As with additional counseling supports above, psychological and nursing services form a supportive approach that principally benefits low-income students, English learners, and foster youth, whose struggles can often lead to disengagement. Their coordination of targeted social-emotional and mental health resources, particularly with the School-Based Mental Health Collaborative, enhances the assistance to unduplicated pupils. Not only do high-need students lack access to such resources, but they require integrated support services because their personal circumstances put them at greater risk of trauma.

Action 5.3 Middle and High School Wellness Centers

Because low-income students, English Learners, and foster youth often lack access to drop-in social-emotional learning and mental health services, the establishment of Wellness Centers substantially increases the support that they receive beyond academics. The Wellness Centers offer individual and group counseling, as well as opportunities to engage in workshops, wellness and mindfulness activities, community building and service learning experiences. The wellness centers offer access to food, personal care and hygiene items, school supplies as well as a clothing necessities closet. These supports help remove barriers to students' success in school.

Action 5.4 Male and Female Leadership Academies

Male and Female Leadership Academies empower unduplicated pupils through academic, cultural, and social-emotional support Male and Female Leadership Academies provide learning opportunities that uplift unduplicated pupils and other students who have been historically marginalized. They provide a forum that amplifies student voices and embraces the community as true partners in education. They also have a distinct emphasis on social-emotional learning, which principally benefits low-income students, English Learners, and foster youth, who experience trauma and related challenges at higher rates than their peers.

Action 5.5 Foster Youth Services

Action 5.5 is limited in scope to Foster Youth, with additional services as described targeting Foster Youth only. Additional social workers will provide social-emotional learning interventions, academic/attendance tracking, intensive case management, and referrals for students The work of the social workers are providing extra support to foster youth and their families. This work includes making improvements to tracking system and communication with our external local agency and County partners.

Action 5.6 Linked Learning Initiative

Linked Learning pathway programs create educational experiences that uplift unduplicated pupils and other students who have been historically marginalized. They provide a forum that amplifies student voices and social-emotional learning, which principally benefits low-income students, English Learners, and foster youth, who experience both academic and non-academic challenges at higher rates than their peers. These programs will increase the graduation rate for foster, EL and low income students by enhancing the connection between the course objectives and life application, thus increasing engagement, growth mindset and self-efficacy.

Action 5.7 Elementary Music Program

The elementary music program increases the opportunities for unduplicated pupils to participate in enrichment activities that ultimately lead to improved academic performance. Unduplicated pupils have fewer opportunities to participate in non-academic programs that support their overall well-being, so elementary music creates experiences that principally benefit them. It promotes the healthy growth and development of children through the study, practice, and performance of music, and develops motor skills, brain functions, study habits, self-esteem, and teamwork – all at a time when they are enduring trauma at higher rates than their peers.

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

With the concentration grant add-on funds and using the responses from community engagement, LBUSD has continued the plan to augment teaching staff at schools with an enrollment of unduplicated students that is greater than 55%. LBUSD hired 91 Full Time Equivalent (FTE) positions- literacy teachers (Goal 3, Action 5 providing additional direct services) in order to support struggling students at campuses with an enrollment with a greater than 55% unduplicated student enrollment. Literacy teachers at the elementary level provide intervention reading skills through either a pull-out program or a push-in model. Literacy teachers provide research-based consistent literacy interventions to students who struggle in reading, writing and speaking. LBUSD ensures that the Literacy Teachers, as described in Goal 3, Action 5, are assigned to schools that serve more than 55% unduplicated students through adding to these sites' staffing quota and each Level Office makes the placements of the Literacy Teachers to the sites.

The addition of literacy teachers aligns with the community engagement themes of: Academic Supports, Literacy Interventions, and Reduction in class sizes.
